Bids will be received for a Single Prime Contract for the construction as shown and noted in the contract documents. A brief summary of the project scope: The Project consists of the construction of a new middle school, approximately one hundred nine thousand

(135,000) square feet. The school will house an administration wing, classroom wings, gymnasium, media center and cafeteria with a full-service kitchen. The building will be conditioned by a combination of split system air conditioning and vertical exterior heat pump; electrical service will be 277/480V & 120/208v additional classrooms, Owner preferred items and a diesel-powered generator (see Section 01 23 00).
