

set in the county in April 1949, received the first picture in June 1949 which was a "skip signal" from WKY-TV Oklahoma City, Oklahoma. There were at that time no television stations on the air in either North or South Carolina. Late afternoon one day after work - and checking over the entire dial, I received a picture from WKY-TV (it only lasted a few

I wrote to the station from programming still later.

On our first television set there were "no stocking distributors," so I wrote directly to Stromberg-Carlson, who shipped the TV by rail freight to the Wadesboro Depot. It was then after installing the new TV and antenna, that every time I passed by the TV I would stop, turn it on and dial through all the channels hoping to get a glimpse of a picture (this is how we received WKY-TV). All this "covered a lot" of time, space and experiments - and what a difference today, this set was a 12 1/2 inch screen, weighed about 150 pounds and now a TV, even with a larger screen would weigh only slightly more than 15 pounds - new TV sets have little or nothing inside to compare with the 1949 model - except the AC cord and plug, they are many dollars cheaper, clearer, sharper, receive better




