# Sheriff's Office Closing in on Church Vandals

Anson County Sheriff's Deputies have arrested one man and have warrants on two other individuals for the November 14th vandalism of Cedar Hill AME Zion Church, located in the

On Monday, April 2nd deputies charged Bryan Matthew Balser, age 21, of Albemarle with Breaking and Entering, Larceny, Damage to Property and Burning a Religious Building. Balser is currently in the Rowan County Jail under similar charges and under a \$1,000,000 bond. A second suspect also is in the Rowan County Jail and warrants were expected to be served on him Tuesday, April 3rd. He is identified as Daniel Tyler Huneycutt, age 19. He will face

The Sheriff's Office also has warrants on a third suspect, but at this time are not releasing that name.

These individuals are believed to have been involved in numerous church and business property vandalism in Anson, Stanly and Rowan Counties. Sheriff Tommy Allen said that his office has been working on this case constantly. "These individuals were our suspects early on in the investigation. We had interviewed them, but they denied any involvement and we just didn't have enough information to make arrests at the time," Allen said. Suspects will all be returned to Anson County to stand trial after their charges in Rowan County have been disposed. Damage to the church was in the tens of thousands of dollars. All repairs have been made

and a re-dedication of the church was made last month.

#### GrowGreen Power Says They are Still on Go for Anson County

GrowGreen Power, an integrator of renewable energy and greenhouse growing systems announced in the summer of 2011 that Anson County had been selected for their next site. Since then talks have seemingly gone silent and the development and building of the greenhouse is nowhere to be found.

The \$250 million GrowGreen Power Center boasted that over 300 permanent jobs would eventually be available here, a huge boost for our county, still struggling with high

Many skeptics feel that GrowGreen has moved on the "greener pastures," and are no longer interested in locating their mega million dollar facility here. "Not true said Mr. Sean Lehman, Director of Communications for GrowGreen. We are currently working our way through the administrative and bureaucratic concerns. Funding was halted during the holidays, and it is, admittedly, taking longer than we anticipated to get this site up and going.

Also, Lehman said, "We are not giving out the exact location of the land selected in Anson County. There are several requirements we are still sorting out."

According to Lehman, the plant, the jobs, the power, the products are all still on go, and an announcement as to their new target date is soon to follow. So do not dismiss the encouraging news of the initial announcement. GrowGreen may still be on go.

#### **Anson County Farmers Face Deadlines** for Direct and Counter-Cyclical **Payments, Other Programs**

Anson County USDA Farm Service Agency (FSA) Acting County Executive Director Amy Yaklin is reminding producers that the 2012 deadline to enroll in the Direct and Counter-Cyclical Payment (DCP) program is Friday, June 1.

"Anson County producers interested in DCP should visit the USDA Service Center where their farm is administered and sign up," said Yaklin. "Enrollments cannot be accepted after the deadline. Enrolling early means avoiding a missed deadline during this busy season.

DCP provides payments to eligible producers on farms enrolled for any of the 2008 through 2012 crop years. The two types of DCP payments, direct payments and counter-cyclical payments, are calculated using the base acres and payment yields established for the farm. DCP is authorized by the Food, Conservation, and Energy Act of 2008 (2008 Farm Bill).

Other FSA programs having enrollment deadlines include: Noninsured Crop Disaster Assistance Program (check with the Anson County FSA Service Center for dates)

• GRAZE-OUT – March 31 for calendar year 2011 crops;

• Conservation Reserve Program (CRP) General Sign-• Average Crop Revenue Election (ACRE) – June 1:

Supplemental Revenue Assistance Payment Program

(SURE) - June 1, 2012 for crop year 2010; • 2011 ACRE Production Evidence – July 15;

• Certification of Planted Acres - Various deadlines, but no later than June 30;

• Farm Reconstitutions (changes) - August 1, 2012 for the 2012 crop year;

• MILC -Sept. 30, 2012; • Crop Insurance - Contact a crop insurance agent or the
