

Two Anson County Bridges to be Replaced

The N.C. Department of Transportation has awarded contracts to replace two bridges

The first contract was awarded for \$2.9 million to Smith - Rowe, LLC out of Mount Airy to replace the bridge on N.C. 109 over Deadfall Creek near the South Carolina line. A new bridge will be built south of the existing bridge, built in 1936.

Traffic will be maintained on-site during construction, with the new bridge complete by August 2022. Vegetation establishment will continue through January 2023.

The second contract was awarded to Sloan Construction, a division of Reeves Construction from Duncan, S.C. The \$5.3 million project will replace the bridge on U.S. 52 crossing Rocky River from Anson County into Stanly County. Crews will build a new bridge to the east of the existing bridge built in 1923.

No offsite detour will be needed since traffic will be maintained on U.S. 52 during construction. The bridge should be completed by June 2023, with vegetation

- Library public computers are available

- COVID-19 vaccines

The following services are not available or have severe limitations:

- GIS Mapping (no timetable for return to service)
- Public Health WIC (1 to 2 weeks for service)
- Office telephones (No timetable for service) As the County recovers from this incident more

information on services will be forthcoming, but recovery will take several months. We ask for your patience as the County and its partners work to restore services to the public and improve its overall IT security posture.
