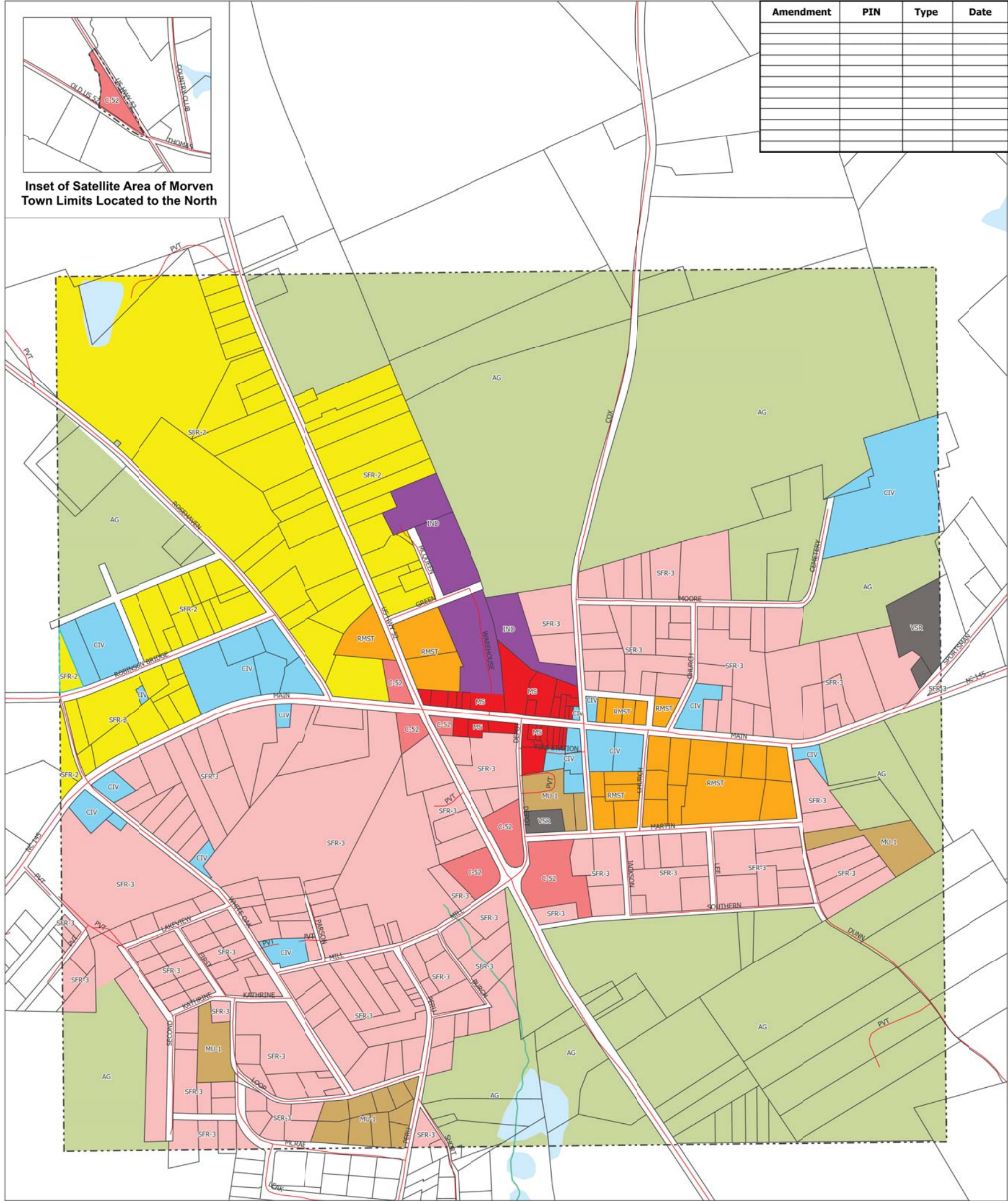
For the new Town of Morven Development Ordinance and Official Zoning Map

Hearing will be held at the Glennie R. Bennett Center, 207 Main Street, Morven, NC 28119

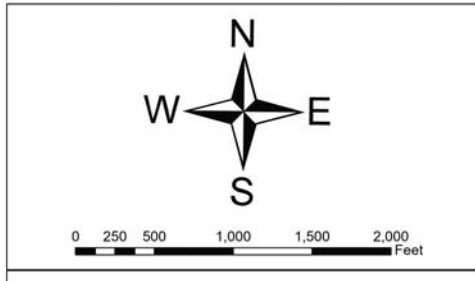
The Town of Morven is expecting growth as North Carolina continues to exceed the national averages. In preparation for the effects of growth in the Town, the Mayor & Town Council have directed the preparation of a new Morven Development Ordinance (MDO) to replace the existing zoning, subdivision, and flood ordinances with a new format that modernizes standards & specifications for land use, development, and new subdivisions. The MDO has been completed and was recommended by the Planning Board on May 26, 2022, to manage development in an orderly and desirable manner. The MDO will formally establish new standards & specifications for such development. The Mayor & Town Council invite you to attend a public legislative hearing to learn about the new MDO and to share your comments. The new MDO including its draft Official Zoning Map is available for inspection at the Town Hall during normal business hours and may be viewed anytime on the Town's website: <https://www.townofmorven.org>
