Two Armed Robberies in Wadesboro


On Wednesday, June 10 at approximately 9:25 p.m. Wadesboro Police officers responded to the Dollar General Store located at 1301 East Caswell Street in reference to an armed robbery. An African American male wearing dark colored clothing entered the store and displayed a handgun, demanding money. There were other customers in store at the time, but no one was injured. The robber left the store with an undisclosed amount of money.

On Thursday, June 11 at approximately 8:58 p.m. Wadesboro Police Officers responded to the Family Dollar Store located at 909 East Caswell Street in reference to another armed robbery. An African American male wearing dark colored clothing and wearing a back pack entered the store displaying a weapon. The robber pointed the weapon at the clerk and demanded money from the cash register. Afterwards the crook ran out of the store and another male subject began to run with him. WPD officers enroute to the armed robbery were able to apprehend one of the suspects and arrest him.

Another arrest was made on Sunday, June 14. Both of the individuals who were arrested were juveniles. They were removed to a Detention Center.
