**Royal Tire Service, Inc.**

This one goes back some years - it was the Cooke Chevrolet dealership location for many years and the only dealership that I can remember locally that had their service department on the second floor. The cars would enter the service department at the back of the building, driving on to the elevator, going to the second floor for service! Crawford Motor Co. purchased the Chevrolet agency in 1959, moving same to their Salisbury Street location.

Along that time Jimmy Burns' father, Herbert Burns, moved the Royal Tire Service from what is now the Wadesboro city hall to the Cooke building after remodeling.

You will note from the above picture, that this was a "big grand opening deal" - I had painted Royal Tire Service, Inc. across the front - and also on the glass windows - "Grand Opening" - "free prizes," "drawing for car," etc.

Herbert, brother Charles Burns, brother-in-law Robert Tyson, Max Randle, Ervin Leons, and Ralph Honeycutt were some of the folks there then. Herbert is now retired, living at Myrtle Beach, SC, while several of above are now deceased - and son, Jimmy is with the Wadesboro Fire Department, something his daddy, uncles and many "older friends" did many years ago!

**Medical Eye Care Program (Preserving or Improving your Vision)**

The Medical Eye Care Program uses every available resource to prevent blindness and restore vision in people who are at risk for losing sight or have lost sight.

The three major causes of blindness are:

- Retinal disorders
- Cataracts
- Glaucoma

The Medical Eye Care Program delivers preventative and corrective services. They may also offer the following services depending on the availability of funds:

**Eye Surgery/Treatment:** If you are a North Carolina resident and do not qualify for Medicaid, we might be able to assist you with eye-related surgery/ treatment. Eligibility is determined by a Social Worker for the Blind. Prior approval for emergency treatment and services will only be given by the state Consulting Ophthalmologist.

**Eye-Related Medications:** If you are a North Carolina resident, do not qualify for Medicaid and have no other resources to assist you, our Medical Eye Care Program might be able to provide medication assistance. Eligibility is determined by the Social Worker for the Blind in your county and approved by the Nursing Eye Care Consultant.

Any applicant/recipient who is dissatisfied with an action or service delivered under the Medical Eye Care Program has the right to request a conference.

**Eligibility** The services provided by the Medical Eye Care Program are offered to the citizens of North Carolina who meet the income scale for this service.
