The Anson County Sheriff's Office continues to warn citizens of fraud and flim-flam scams that are reported regularly to the Sheriff's Office. Generally, these are some form of mail, fax, telephone or e-mail scams, notifying individuals they have won money from some contest, lottery or third world individual who is asking for help getting money back into the United States. Sheriff Tommy Allen said that the old rule still applies, "If

it sounds too good to be true, it almost always is." stack of Award Notifications, Lottery Payment Processing Forms, Claim Center Notifications, USA Survey Network (and the list goes on and on), who have contacted local citizens on their "winnings" and ask the individuals to send them a 'processing fee, finders fee, or tax fee' for helping them with the contest, that of course they never entered. These letters will often be postmarked Canada or some third world country or even an island resort. Do NOT call the phone numbers listed on these letters. Sometimes that is the only thing they are trying to get you to do. You may be billed hundreds of dollars for that one "international" call.

Two things to always remember: 1) You will never win any lottery, contest or drawing that you have NEVER entered; and 2) NO legitimate contest will ever ask you to send money back

to them under any circumstances.
