Bradley Stuart Baucom Charged in Shooting Eldric Jovan Polk Last Tuesday

On Tuesday, October 18th at 3:11 p.m. Sheriff's Deputies and EMS were called to a shooting in the Burnsville Community off Ivy Road. The victim of the shooting was

identified as Eldric Jovan Polk, age 34. Polk was wounded by a grazed gunshot wound and glass from a shattered storm door that was broken by a gunshot. Polk was treated and released from the hospital.

Deputies arrested Bradley Stuart Baucom, age 37, of Little Road in Polkton. Baucom was charged with Assault with a Deadly Weapon Inflicting Serious Injury. His bond was

set at \$200,000. He is currently in the Anson County Jail. Sheriff Tommy Allen said that Baucom had been at the Polk's residence earlier, left and returned with a handgun and fired the gun at Polk one time. "Neither Polk nor Baucom were clear as to what their dispute was about, but I think we have a pretty good idea. Baucom is lucky he's not being charged with murder," Allen said. Baucom remains in the Anson County Jail at this time.

While many people were just waking up, 300 volunteers were hard at work completing 39 projects across Anson County during United Way Day of Caring on Saturday, October 1st.

Will You Contact a County Commissioner on an Animal's Behalf?

Last week I was contacted by Richmond County Humane Society board member Evonne Swanson, who was feeling defeated and overwhelmed by goings on in the facilities of the

Richmond County Humane Society. Swanson explained that funding for their facilities is provided through grants to go towards the proper feeding, medical care and placement of animals within Richmond County. However, due to the excessive amount of animals they are accepting from Anson County, they are at maximum capacity and nearing a point of no admittance. What that means in a nutshell is this...If an animal is turned away by their facility, it will most likely be set free or sent to the dog pound - there facing almost certain death. "We do not want to be forced to turn any animal away, but we simply cannot afford to continue without assistance," said Swanson.

Take-back event offers public safe, secure way to dispose of their medications

The Anson County Sheriff's Office, in collaboration with Safe Kids Anson County and the Anson County Partnership for Children, is pleased to announce the 3rd Biannual Operation Medicine Drop in Anson County. The event is planned for this Saturday, October 29th at Food Lion in Wadesboro. Sheriff's Deputies and Safe Kids Anson County volunteers will be available from 9am until noon for citizens to drop off expired, unused prescription or over-the-counter medications. The last Operation Medicine Drop in Anson County was very successful. Held in March of this year, over 11,000 doses of medication were dropped off for proper disposal.

Many may not realize that unintentional poisoning from prescription medications is on the rise in North Carolina. Since 1999, nearly 4,500 people have died from prescription poisoning. Operation Medicine Drop offers the public a free and convenient option for disposing of their prescription and over-the counter medications to protect their families and the environment.

Health Department, who agreed, "There is a problem, and my suggestion would be to become more proactive about spaying and neutering your pets." Additionally, Gibson advised that a proposal should be written up and presented to the Anson County Commissioners, which Swanson has agreed to do. That proposal would ask that funding be provided to Richmond County, however, for assistance in taking in pets from our county.

In recent years I myself have been involved with several animal rescues and personally know of instances where animals have been taken to Richmond County to protect them from euthanasia. Without an active Humane Society here, to create one we are faced with a situation that will require a number of people, a lot of money, dozens and dozens of volunteers and their tireless efforts, housing facilities and the list goes on. In other words, there are no easy solutions. As I recall, I have written about the problems with lost, abandoned and stray animals in our county on a number of occasions, asking for help and assistance. Many others have done the same, but for whatever reasons, without much of an impact.

Perhaps we as citizens of a county without an active Humane Society should ask our county officials for help. And, let's take that a step further...If our county officials do not hear from us, the citizens, specifically about problems which exist with regard to the humane treatment of animals, then they cannot be expected to help. Animals cannot speak on their own behalf. It is our duty to protect them. I ask that you contact the County Manager, Mr. Lawrence Gatewood, or any of our County Commissioners. That would be a start. Some, if not all, may not even be aware a problem exists. Communication is certainly the key. It could be that Anson County could use the Richmond County Humane Society services for about the same cost or little more cost than the expenses involved in running our present dog pound...with far superior treatment of the animals. Lost animals would have vastly improved chances of being returned home, and adoptable animals would have so much more opportunity to survive and end up in loving homes.
