Bill managed WADE Radio station in Wadesboro for many years. He was extremely well known in the community, with many friends. Bill was also known nationwide for his pitch-perfect and authoritative 'radio voice.'

Due to a computer mishap, it appeard that Bill's "TnT" columns were lost. But, after working on the project for several years, we have managed to recover at least some of his work. Because of that good fortune, we are proud to present a column below that Bill wrote for the November 10, 1999 edition of The Express.

Billingsley's This and That

First in this piece I'd like to tell you of a conversation I had with Johnny Hill of Chesterfield Road in Wadesboro. It's an intriguing story – one that you may find a little strange.



Before Johnny retired he had begun to store stuff in a barn behind his house, so when he retired he would have some things to work with and occupy his time.

One of the things Hill had stored in the barn was an old 8-N Ford tractor, which did not run. After he retired, he planned to do some work on it to get it running again.

On a visit out to the barn and just looking around, at nothing in particular, he glanced over at the old tractor. He discovered that someone had "borrowed" the carburetor off of it. Nothing but the carburetor! This seemed to be strange, in itself. He had already missed some things from the barn but all that was understandable – but never just a carburetor taken off a machine!

Then, on a subsequent visit there, just looking around again, Johnny noticed a plastic bag beneath the tractor and realizing that the bag contained something, he took a closer look. And, to his surprise, there was the carburetor all clean and like new. Now, as Paul Harvey might say, "Here's the rest of the story."

Not only did Johnny Hill not have to reclean the missing piece from the 8-N Ford tractor, but he put it back on and got the thing running. It's running today. Runs like a top.

You will recall the article of some time ago about passenger trains that came through Wadesboro on the Seaboard Airline Railway.

This story caused enough interest in Mrs. Margaret R. McRae for her to write to me and reminisce about the times she rode the "Silver Comet" from Wadesboro to Birmingham many times. Her daughter, Margaret, who attended Agnes Scott College in Decatur, used it for four years. She points out in her letter that whether or not it (The Comet) was going or coming, although it was supposed to arrive here at midnight – it was always late. Mrs. McRae remembers sitting in the Wadesboro Depot, freezing although huddled close around the customary railroad "Pot Belly Stove."

When the train finally stopped, it was never in the right place for boarding and disembarking.

Her husband, Martin A. McRae, about whom we wrote in a past column, got so fed up with the running back-and-forth he wrote the big boss of the Seaboard saying he was no longer a young man and asked if he would stop the train with the coach in which their daughter rode nearer the station. Soon, a letter came from headquarters saying they would do everything in their power to accommodate Mr. McRae.

Mrs. McRae still has those letters and newspaper clippings that she has saved for many years.

She even mentions the "Silver Meteor" which ran from N.Y. to Miami – reminding me that you either had to go to Hamlet or Cheraw to meet it. It, too, was never on time.

I don't remember telling you that and one named simply number 92, was the one we took my father to and got him from.

Mrs. McRae also pays some high complements to The Express and this effort. Thank you Mrs. McRae!

I appreciate every card, letter, telephone call, scrap of paper handed me or person to person conversation. Since I don't take shorthand, I may ask you to slow down as I make notes. You see, I am quite a bit older now than I was when I was a broadcaster, so, I can't possibly remember as I once did.
