January is Cervical Cancer Awareness Month

The health department is providing a free educational session on cervical cancer on Thursday, January 30, from 3:00 to 4:00 p.m. Feel free join.

January has arrived, a month where so many around have made New Year resolutions that are soon to be broken. This year, the Anson County Health Department encourages every woman to make a well-women exam the one resolution to keep. The American Social Health Association (ASHA) and the National Cervical Cancer Coalition (NCCC) has named

January Cervical Health Awareness Month. This is a special month where women encourage women to get screened for cervical cancer and receive the human papilloma virus (HPV) vaccine if they are eligible.

Cervical cancer is the 3rd leading cause of death amongst women in the United States and affects nearly 12,000 women a year in the U.S. alone. All women are at risk for cancer, however it occurs more often in women 30 and older. According to the statistics presented in 2014 from the Center for Disease Control (CDC), Hispanic women had the highest rate of getting cervical cancer followed by black, white, Asian/Pacific Islander, and American Indian/Alaskan Native women. Reports also revealed that black women are more likely to die from cervical cancer. According to the American Cancer Society (ACS), in 2018 about 13,240 new cases of aggressive cervical cancer will be diagnosed and about 4,170 women will die from the disease.

Most cervical cancer is caused by human papilloma virus (HPV). HPV is a group of 150 or more related viruses and is contracted through sexual intercourse. Some types of HPV can cause genital warts, while high-risk HPV types are linked to cervical cell changes that lead to cervical cancer if not detected early. More than 70 percent of cervical cancer cases come from high risk HPV types. The CDC recommends all boys and girls get the HPV vaccine by age 12. The vaccine is available through the age of 26 to prevent the virus and cervical cancer. To prevent and detect cervical cancer, a Pap test is recommended every 3 years for women between the

ages of 21-60. A Pap test can find cell changes to the cervix caused by HPV. HPV tests find the virus and help healthcare providers know which women are at highest risk for cervical cancer. An abnormal Pap test may require a detailed follow-up. The Anson County Health Department provides the HPV vaccine to both boys and girls between the ages of 9 and 26 and accepts most major insurances. Young uninsured women under the age of 19 can receive the

vaccine free of charge. The Health Department also provides the Pap test. The health department is located at 110 Ashe Street in Wadesboro. For more information about the HPV vaccination please call (704) 694-5188.

N.C. REAL ID

Beginning October 1, 2020, federal agencies will enforce the REAL ID Act, which requires a REAL ID, U.S. passport or another federally approved identification to board commercial flights and enter secure federal buildings.

The N.C. REAL ID is a REAL ID Act-compliant driver license that is just like a traditional license or ID but has a star at the top. Driver licenses and IDs without a gold star are noted "Not for Federal Identification."

N.C. REAL ID Is Completely Optional You do not need an N.C. REAL ID driver license or identification card to do any of the following: Drive, Vote, Apply for or receive federal benefits (e.g., Veterans Affairs, Social Security Administration, etc.), Enter a federal facility that does not require an ID (e.g., a post office), Access a hospital or receive life-saving services, or Participate in law enforcement proceedings or investigations (e.g., serve on a federal jury, testify in federal court, etc.) An N.C. REAL ID, however, might be helpful for anyone who frequently: Boards a commercial airplane, Visits

nuclear sites, Visits military bases, and/or Visits federal courthouses, federal prisons or other federal facilities An individual without an N.C. REAL ID or U.S. passport will still be able to board flights or make visits to the

facilities mentioned above, but they will have to provide additional documentation with their traditional license or Getting an N.C. REAL ID Even though the federal law is not effective until October 1, 2020, anyone can get

an N.C. REAL ID now. To do so, visit an N.C. Division of Motor Vehicles driver license office with the required acceptable documentation: • One document (with full name) proving identity and date of birth

 One document (with full name and full Social Security Number) confirming Social Security number • Two documents (with current physical address) proving North Carolina residency

• For non-U.S. citizens, one document (with full name) proving legal presence/lawful status • If applicable, one or more documents verifying any name change

What to Expect for Your REAL ID Visit The N.C. REAL ID will make it more convenient to board a

commercial airplane if you don't have a passport or visit a military base or other federal facility, but it isn't required and won't be needed until October 2020. If you're headed to a N.C. Division of Motor Vehicles driver license office to get yours, here is a list of things

to expect during your first visit: If you did not schedule an appointment, be prepared to wait a bit longer as there are more people visiting the

office for their first REAL ID, too. Your identity and residency documents will be reviewed at check-in.

You will take a vision test.

You will take a new photo.

 You will receive a temporary identification certificate or a temporary driving certificate to use until you receive the actual card in the mail.

• Your temporary ID or license will not have a star, but the actual card will include the star when mailed to you. Other Details to Know Your first N.C. REAL ID cannot be obtained online. It can only be issued at a driver license office, where required

documents will be scanned and permanently stored, as required under federal law, in your NCDMV record.

• Getting an N.C. REAL ID driver license or ID card costs the same as getting any other license or ID for the first time, and the process is similar. ullet If you get an N.C. REAL ID outside of the renewal period, the cost is \$13 — the same as a duplicate license or

ID card. You will have to take a new photo, but no tests are required. • The cost is the same as a renewal, if the REAL ID is obtained within six months of expiration. You will have to

take a vision test and take a new photo. · Applying for a North Carolina driver license or ID card will cancel any licenses or ID cards from other states through the State-to-State Verification program.

Effective at 7 a.m. on Wednesday, January 8, Atrium Health

This unified response also helps better control the spread of flu throughout the region. Atrium Health hospitals affected by the tighter visitation

policy are: Atrium Health's Carolinas Medical Center, Atrium Health's Levine Children's Hospital, Atrium Health's Levine Cancer Institute, Atrium Health Cabarrus, Atrium Health Mercy, a facility of Carolinas Medical Center, Atrium Health Pineville, Atrium Health Union, Atrium Health University City, Atrium Health Lincoln, Atrium Health Cleveland, Atrium Health Kings Mountain, Atrium Health Anson, Carolinas HealthCare System Blue Ridge, Atrium Health Stanly, Atrium Health Behavioral Health Charlotte, Atrium Health Behavioral Health Davidson, Carolinas Rehabilitation-Charlotte, Carolinas Rehabilitation-NorthEast, Carolinas Rehabilitation-Mt. Holly and Atrium Health Pineville Rehabilitation Hospital.

Atrium Health is also asking individuals of all ages who are experiencing flu-like symptoms to help control the spread of the illness by not visiting patients in the hospital while ill with flu like symptoms. Symptoms of flu include: fever, headaches/body aches/pain, cough or sore throat, stuffy or runny nose, chills, fatigue, nausea, vomiting and/or diarrhea.

If extraordinary circumstances require an individual with flu-like symptoms to visit a hospital patient, the visitor will be asked to wear a surgical mask to protect themselves and others. To reduce your risk of getting the flu, Atrium Health recom-

mends frequent hand washing with soap or use of an alcoholbased hand sanitizer, not touching eyes, nose or mouth with hands, covering your cough/sneeze, and getting a flu shot. Most people with the flu have mild illness and do not need medical care. If you have flu-like symptoms, in most cases you

should stay home and avoid contact with other people. Flu

sufferers should rest, drink fluids and take ibuprofen or acetaminophen to reduce minor pain or fever. If you are concerned about the severity of your symptoms, contact your healthcare provider or start a video visit or eVisit. The emergency department should only be used for people who are very sick, such as those with difficulty breathing, chest

pain, confusion, severe vomiting or signs of dehydration.
