# 2 Killed in Monday Shootings

Two men, Jerry Thomas Rorie, 25, and Marcus Antonio Allen, 24, were killed on Monday, January 7 on Salisbury Street in Wadesboro. Wadesboro Police are continuing to investigate what they suggest may be a case of gang related violence.

At about 6 p.m. officers responded to a call to a convenience store on Salisbury Street concerning a gunshot victim who had collapsed there. Upon arrival the officers found the collapsed man, and he was taken to Anson Community Hospital where he died later from his wounds. During the investigation officers discovered a second man dead in the driveway of a nearby home on Salisbury Street. He was also shot.

Police said that members of two gangs apparently had a confrontation at a Salisbury Street house which resulted in gunfire. Each victim was from a rival gang. The victim found in the convenience store had run from the confrontation after being shot.

As of press time the investigation was ongoing and no arrests have been made.

#### Morven Man Killed in Home Fire

The Anson County Sheriff's Office investigated a fatal house fire in Morven. Deputies and the Morven Fire Department responded to a house fire at 1:16 a.m. on the morning of December 31st. The house was fully engulfed in flames when responders arrived at the scene at 6425 Robinson Bridge Road. When the flames were extinguished firemen found the body of James McCray, age 72, near the back door of his residence. Mr. McCray lived alone and had limited mobility.

Investigators at the scene believe the fire started in Mr. Mc-Cray's bedroom where at least one space heater was located. Investigators will await the results of the autopsy and other analysis before making a final determination as to the cause of the fire.

## Michelle Herndon and Michael Lawhorn Busted for Meth Lab

The Lilesville Police Department and Anson County Sheriff's Office responded to Fifth Street in Lilesville on January 1st at 1:30 p.m. in reference to a fight. That led officers to 313 Fifth Street where officers discovered drug paraphernalia located inside the residence. A narcotic search warrant was obtained by the Lilesville Police Department for the residence. The resulting search uncovered a lab where methamphetamines were being produced.

Michelle Herndon, 49, and Michael Lawhorn, 33, were arrested and taken to the Anson County Jail. They are charged with Felony Possession of Precursor Chemicals to Produce Methamphetamines, and Manufacturing Methamphetamines. More charges could be pending due to the proximity of the residence to the Lilesville Elementary School.

begun enforcing the ban on video sweepstakes operations and machines beginning January 3rd. "The NC General Assembly passed new laws banning such operations in 2010, but the ban had been tied up in court rulings over the past two years. The NC Supreme Court recently unanimously overruled a lower court decision and upheld the ban on sweepstakes operations," Sheriff Allen said.

Sheriff Allen said that he and his officers had personally visited every known operation in the county and given the operators notice of the coming ban.

To assist the Sheriff, the Wadesboro Police Department, whose jurisdiction has the largest number of machines, and other police departments around the county have done the same notifications for those businesses operating inside city limits.

"I believe we've given these operations adequate notice and are working with them to comply. We're just enforcing the law that was passed by the General Assembly and recently upheld by the Supreme Court. We recently met with the District Attorney on the matter as well. We've notified every location we are aware of that has these operations or has stand-alone machines. Everyone we've spoken to has been corporative. If we've missed any location or machine I hope someone will give us a call," Allen said.

State Attorney General Roy Cooper said there weren't widespread internet café raids across the state on Thursday. "Enforcement will likely vary across the state depending on the discretion of local officers and district attorneys," Cooper said.

# North Carolina's Oldest Breast Cancer Survivor Dies at 103

Mrs. Nannie Sue Neal, the woman known as the "Oldest Living Breast Cancer Survivor in North Carolina," has passed away at the age of 103 years-old. Mrs. Neal died Thursday morning at home in Waxhaw with her family. She was born on October 15, 1909.

Mrs. Neal was a 59-year survivor of breast cancer. Her granddaugther Bettylyn Krafft said that her recipe for such a long and healthy life was living a, "very healthy lifestyle by watching and cataloging her diet to eat the right foods. She always practiced portion control!"

Mrs. Neal's daughter, Betty Boyd, was a former resident of Anson County.

In 2011 Mrs. Neal, whose birthday was in October which is Breast Cancer Awareness Month, was named the Honorary Race Director for the Dollar General 300 Miles of Courage NASCAR Nationwide Series race at Charlotte Motor Speedway. She went to CMS and was honored on her 102nd birthday with a ride around the track in a pink race car driven by NASCAR driver Kenny Wallace.

Firn concluded, "In the future, when we think back, Anson County will always bring a smile because of just how special this place is.
