1,665 Reported Cases of COVID-19 in Anson County

As of Monday, January 11 the Anson County Health Department posted that Anson County had 1,655 reported cases of COVID-19. 245 of those cases were active. At that point they had discharged 1,420 cases, 1,383 to baseline health and 37 deaths.

The NC Department of Health and Human Services (NCDHHS) reported statewide as of Monday, January 11 there were 629,124 total cases of COVID-19, with 7,578 deaths, 7,611,324 completed tests and 3,843 hospitalized Statewide, as of Monday, January 4 there were 570,111 total cases of COVID-19, with 6,941 deaths, 7,119,201 completed tests and 3,192 hospitalized. On Monday, December 7 there were 404,032 total cases of COVID-19, with 5,605 deaths, 5,678,794 completed tests and 2,373 hospitalized. On November 2 there were 278.028 total cases of COVID-19, with 4,390 deaths, 4,116,019 completed tests and 1,146 hospitalized. On October 5 there were 219,754 total cases of COVID-19, with 3,637 deaths, 3,188,371 tests and 971 hospitalized. Health Department Has Begun Phase 1b Covid-19 Vaccinations

The Anson County Health Department started Phase 1b COVID-19 vaccinations on Monday, January 11. This phase is for people 75 and older. If you haven't scheduled your vaccine please call 704-694-5188 option 1 and they will get you scheduled. Anson County Emergency Management assisted with the drive-thru clinic.

• Phase 1b: Adults 75 years or older and frontline essential workers. There is not enough vaccine for everyone in this phase to be vaccinated at the same time. Vaccinations will be available in the following order.

- **Group 1:** Anyone 75 years or older regardless of medical condition or living situation. People do not have to have a chronic health condition.

- Group 2: Health care and frontline essential workers who are 50 years of age or older.

- **Group 3:** Frontline workers of any age and health care workers of any age, regardless of whether they work directly with COVID-19 patients. This phase is anticipated to begin in early January.

The CDC defines frontline essential workers as first responders (firefighters, police), education (child care, teachers, support staff), manufacturing, corrections officers, public transit, grocery store, food and agriculture, and US postal workers.

Anson County School District Update

This is a release from Anson County Schools: Anson County Schools has made the decision to continue with Plan C, which is 100 percent remote learning, for all Anson County students through Friday, January 29.

This decision was made due to the increase of community transmissions of COVID-19 and to keep our school family safe. All learning will continue remotely. If there are any further changes or updates, we will notify all students, parents and staff as soon as possible. As always, our priority will be the safety and well-being of our students and staff.



Governor Cooper Extends Modified Stay At Home Order Amid Rising Case Counts

Modified Stay At Home Order extended as numbers continue to increase at alarming pace; 96 counties now designated as "red" or "orange."

North Carolina National Guard mobilized, other efforts underway to support vaccine distribution.

On Wednesday, January 6 Governor Roy Cooper and North Carolina Department of Health and Human Services Secretary Dr. Mandy Cohen shared an update on North Carolina's efforts to prevent the spread of COVID-19 and support the vaccination effort currently underway.

Governor Cooper extended North Carolina's Modified Stay At Home Order that requires people to be at home from 10 pm - 5 am to last through at least Friday, January 29. Secretary Cohen also issued a Secretarial Directive with stark warnings for North Carolinians to avoid indoor spaces without masks and gatherings between households.

"We have turned the page on a new year – one that we're hoping will bring better times. But as we know, the virus didn't disappear at midnight on December 31, Governor Cooper said. "In fact, in North Carolina, we have seen some of our highest case counts, percent positives, hospitalizations and ICU bed usage numbers in the past few days. No matter where you live, work, worship or play, COVID-19 remains a deadly threat and we must treat it that way "We are in a very dangerous position. North Carolinians need to take immediate actions to save lives, slow the spread of the virus, and protect hospital capacity so that medical care is available to anyone who may need it, whether for COVID-19 or for any other reason," said NCDHHS Secretary Mandy K. Cohen, M.D. Dr. Cohen also provided an update on North Carolina's COVID-19 County Alert System map. There are now 84 counties designated as red (critical community spread) and 12 counties that are yellow (substantial community spread). Anson County is designated as red. Vaccine Efforts Underway Governor Cooper and Dr. Cohen also highlighted North Carolina's efforts to support the COVID-19 vaccination campaign. Governor Cooper has mobilized approximately 50 North Carolina National Guard personnel to support NCDHHS and North Carolina Emergency Management. The Guard will assist with administering the vaccine and logistics support for local entities. "As we work to prevent the spread of COVID-19, we are also helping local hospitals and health departments to support their vaccine efforts. Getting the vaccine out quickly is the most urgent priority right now, and we will use everything and everyone needed to get the job done," Governor Cooper said. NCDHHS is onboarding more health care providers to administer the vaccine and sharing detailed guidance with providers to help them get the vaccine out more quickly. NCDHHS has also notified vaccine providers that future allocations will be based on how quickly they are able to get their supply out to eligible recipients. If an entity is not using their vaccine supply quickly enough or keeping the state database updated on their progress that will impact how much they are allocated going forward. As the state moves into Phase 1b, local hospitals and other vaccine providers can now begin administering vaccines to those over age 75. Individuals should call their local health department or hospital to see if they have started to schedule vaccine appointments. In Anson County call the Health Department at 704-694-5188. Finally, NCDHHS and the state of North Carolina continue to work with communities around the state who may be hesitant to accept the vaccine when it is their turn. Governor Cooper and Dr. Cohen underscored that this vaccine was authorized after independent health experts reviewed the data from tens of thousands of trial participants.
