### Wadesboro License Plate Agency **Contract Expires June 2014**

DMV seeking contract applications by February 10

The North Carolina Division of Motor Vehicles announced that it is accepting applications for a Wadesboro area license plate agency. The current agency operates under a contract that will expire in May 2014.

The policy of the Division is to open applications to operate a license plate agency whenever a contract expires or ends. The current agency, located at 101 South Greene Street in the Anson County Government Building, will continue to operate during the application process and its contractor may reapply to operate the business. Routinely it takes about four months to complete the application process.

Plate agency applications (Form MVR-93 or Form MVR-93AA) are located on the Connect NCDOT website. Interested applicants are invited to download an application form for a motor vehicle LPA or call (919) 861-3332 with questions. The application must be returned to NCDMV no later than Monday, February 10, 2014.

LPAs offer vehicle registration services and title transactions, as well as vehicle license plate renewals, replacement tags and duplicate registrations. Currently about 120 license plate agencies operate across North Carolina.

## **New Driver Licenses Will Reduce** Fraud, Better Integrate Technology

The North Carolina Division of Motor Vehicles is moving forward with production of a new next generation, secure driver license that will reduce the risk of identity theft, better integrate new technology for customer service and comply with the federal Real ID Act of 2005.


N.C. Department of Transportation signed a \$73,468,000 contract on Dec. 16, with MorphoTrust USA, Inc. of Billerica, Mass. to produce more than two million new driver licenses and ID cards per year, enabling NCDMV to achieve its modernization efforts. MorphoTrust is the company that currently produces North Carolina Driver licenses.

The new contract replaces a previous agreement with MorphoTrak after that company missed several key deadlines beginning in 2011, and faced a series of stop work orders before the contract was terminated by mutual agreement in December 2013.

"I really appreciate the NCDOT team effort to resolve the previous issues and secure this new agreement which will allow us to effectively complete this important project with the most efficient use of taxpayer money," said NCDMV Commissioner Kelly Thomas. "The new license and ID cards will bring us into compliance with federal and industry standards and provide secure identification capabilities for us into the future as we continue to improve customer service.

The new agreement, which expands beyond the original project scope to make NCDMV more adaptable to changes and customer needs, is expected to enter pilot production of the new driver license credentials and processes by the fourth quarter of this year, and begin full-scale production by early 2015.

The new license and ID card systems will provide real-time facial recognition capabilities, lower operational and maintenance costs, integration with smartphones and tablets, a mobile solution to expand NCDMV's ability to issue credentials to rural and outlying areas, and introduces a limited number of full-service kiosks to enhance customer convenience and service. It is also designed to further improve customer service through the deployment of multiple customer enrollment workstations rather than the single photograph stations in driver license offices today. This is expected to significantly reduce customer wait times.

#### **Protect Yourself from Medicaid Card Mix Up**

Families whose Medicaid cards were sent to the wrong addresses can take steps to guard against possible identity theft and health care fraud, Attorney General Rov Cooper said. The North Carolina Department of Health and Human Services recently announced that it mailed 48,752 Medicaid cards for North Carolina children to the wrong addresses. According to DHHS, the cards include children's names, Medicaid identification numbers, dates of birth and the names and addresses of their primary care physicians but do not contain Social Security Numbers.

Misusing a Medicaid benefit card is a felony, and Cooper's Medicaid Investigative Division has prosecuted people in the past for such crimes.

Parents of children whose health insurance cards wound up in the wrong hands are understandably concerned," Cooper said. "Taking a few simple steps can give families peace of mind that their child's information isn't being misused.'

Parents and legal guardians of children whose Medicaid cards went to the wrong address should:

• Contact the three credit bureaus to see if your child has a credit report. In most cases, children under 18 will not have a credit report: Equifax 1-800-525-6285; Experian 1-888-397-3742; and TransUnion 1-800-680-7289. If your child has a credit report, request a fraud alert from the credit bureau.

• Freeze your child's credit report, if your child has one. A security freeze prevents anyone with your child's personal information from taking out a loan or credit card in his or her

#### **Farm Transition Conference for Farmers and Landowners**

Farmland loss is an extremely important issue in North Carolina. For example, Moore County lost 20,000 acres in farmland in the five year period ended in 2007. Richmond and Moore County Cooperative Extension Offices are teaming up with Mount Olive College to deliver tools to help farm families hold onto their farms in succeeding generations.

Mount Olive College's Lois G. Britt Agribusiness Center will partner with NC Cooperative Extension Centers across central North Carolina to conduct a farm transition conference for area farmers and landowners. Mount Olive College and Cooperative Extension have conducted farm transition regional events and educational workshops in eastern North Carolina and are now working to respond to the need in the central part of the state as well.

This effort will be a comprehensive review of farm transition and the tools and resources that are available to assist landowners with farm transition and estate planning. Dr. Ronald Hanson, a nationally recognized farm succession specialist from the University of Nebraska-Lincoln as well as several state and local estate planning specialists will be on the agenda. The workshop topics will include:

• Farm Transfer Issues • Family Farm Business Ownership Succession • Estate Planning Tools • Present Use Value • Transferring Forest Assets.
