1,759 Reported Cases of COVID-19 in Anson County

As of Friday, January 15 the Anson County Health Department posted that Anson County had 1,759 reported cases of COVID-19. 241 of those cases were active. At that point they had discharged 1,518 cases, 1,479 to baseline health and 39 deaths. The NC Department of Health and Human Services

(NCDHHS) reported statewide as of Monday, January 18 there were 674,637 total cases of COVID-19, with 8,083 deaths, 8,022,425 completed tests and 3,862 hospitalized Statewide, as of Monday, January 4 there were 570, 111 total cases of COVID-19, with 6,941 deaths, 7,119,201 completed tests and 3,192 hospitalized. On Monday, December 7 there were 404,032 total cases of COVID-19 with 5,605 deaths, 5,678,794 completed tests and 2,373 hospitalized. On November 2 there were 278.028 total cases of COVID-19, with 4,390 deaths, 4,116,019 completed tests and 1,146 hospitalized. On October 5 there were 219,754 total cases of COVID-19, with 3,637 deaths, 3,188,371 completed tests and 971 hospitalized.

Health Department's Drive-Thru Covid-19 Vaccinations Now Take Place at Emergency Services Center

Effective Tuesday, January 19, the Anson County Health Department's daily drive-thru COVID vaccination clinic now takes place at the Anson County Emergency Services Center, located at 2230 Country Club in Wadesboro.

Fred G. Thompson, PhD, Health Director at the Anson County Health Department, said, "This change in tor COVID vaccinations will protect staff from the weather and make it easier for EMS to support our vaccination clinic on an ongoing basis."

Also, at the request of the federal government, North Carolina has adopted a new vaccine phasing schedule which was effective Thursday, January 14. The big change is opening up eligibility to anyone 65 and over.

Thompson continuted, "While I am thrilled to see eligibility open up to anyone 65 and over, it is critical for the community to understand that the supply of the vaccine is very limited at this time. We have over 1,000 Ansonians with reservations to get vaccinated and we are only getting 100 doses of the vaccine this week. We will get everyone scheduled and vaccinated as vaccine supplies are made available to us.'

Thompson concluded, "While we have extra staff manning the phones, we are getting hundreds of calls every day, literally crashing the phone system at times. People may have to leave a voicemail. We will call them back as quickly as possible. Thank you and feel free to reach out to us with your questions.'

According to the award presenters, Wadesboro Police Chief Thedis Spencer and Lieutenant Steven Kelly, to earn the Medal of Valor an officer would have performed an act of displaying extreme courage while consciously facing iminent

Legrand and Phan earned the award from an incident that took place in the spring of 2020. Chief Spencer related the incident: "On May 26, 2020, Wadesboro Police officers responded to a call for service in reference to discharging a firearm. After observing a vehicle erratically fleeing the area of where the gunshots were coming from, officers attempted to stop the fleeing vehicle. The vehicle failed to stop and ended up in the area of an apartment complex. The suspects promptly exited the vehicle therein leading Wadesboro Police officers on a foot chase.

Patrol Officer Phan and School Resource Officer Legrand closely pursued one of the fleeing suspects on foot. The fleeing suspect then pulled a weapon and fired upon Legrand, striking him in the abdomen. Determined to finish the engaged gunfight, Legrand displayed mental fortitude and physical resilience when, despite his injury, he was able to get to cover and exchange gunfire with the suspect.

As the foot chase continued, the fleeing suspect continued to fire his weapon at officers. Phan, too, was struck in the area of his duty belt, where the bullet lodged into his magazine pouch. With concern for his injured comrade and the safety of the general public in mind, Officer Phan displayed impeccable bravery and mental fortitude when he disregarded his own well-being and exchanged gunfire with the suspect, ultimately neutralizing the threat.
