

## Info About the Anson County Health Department Clinic

### To be seen for services at Anson County Health Department Clinic

Effective February 1, 2015, Anson County Health Department will no longer accept a client's declaration for income verification. All programs and services which require the application of the "sliding fee scale" for services received must have documentation of household members and income for all household members before qualification for the sliding fee scale can be completed. Clients will not be denied services if they do not have documentation on date of service. However, they will be charged at 100% and given 15 days from date of service to provide documentation. Failure to provide documentation in the allotted time will result in 100% charges standing for provided services.

#### Who is Required to Bring in Documentation:

- Clients with insurance that is accepted by Anson County Health Department must provide financial documentation for sliding fee scale to be applied to copayments and amounts applied to deductible of insurance.
- Clients who have insurance but is not accepted by Anson County Health Department. These clients will be treated as a self pay client.
- Self Pay - Clients who have no form of insurance and request services in which the sliding fee scale must be applied.

#### Exceptions:

- Clients for services who have active Medicaid which will cover the services provided.
- Clients who chose to waive providing documentation and be charged at 100% for all applicable services.
- Clients who request "flat fee" services, i.e. TB Skin Test, Immunizations, certain procedures, will not be required to provide documentation as the sliding fee does not apply to these services.
- Clients who request services in which the sliding fee does not apply, i.e. std clinic and communicable disease.
