Book By and About Polkton Native Henry Fulton Griffin (1867-1893) is Available

Dear Editor,

Last week you published the obituary of my mother, Margaret Savage. I live in Tennessee and would like to introduce you to a book of letters by my cousin in Colorado concerning Henry Fulton Griffin, who is buried in the Old Davis-Griffin Cemetery in Polkton. The title is "Henry Fulton Griffin, 1867-1893, A Portrait through Correspondence."

The book is a compilation of letters from, to, about my Great Uncle Fulton after he left Polkton to go to college and pursue a profession in the law field. The letters, which were handwritten, of course, were preserved by his father, then passed to my aunt, who preserved them for her son, my cousin, Rhys Llewellyn. Rhys then spent about two years transcribing them into what now is a very wonderful book of insights into post Civil War life in Polkton, surrounding counties, other states, and even in Washington, DC, where he was in law school and then worked.

From The Express: Here is the information offered at *www.thesnowbirdpress.com*: This book is a collection of letters, primarily written to or by Fulton Griffin, a bright, young, noble scholar from North Carolina. The correspondence reflects not only Fulton's daily pursuits but also his very promising future, cut short by a tragic accident at the Chicago World's Fair of 1893. Letters from family, friends, co-workers, and classmates, provide a glimpse into post-reconstruction America in the 19th Century and Fulton's own experiences living and working in Washington D.C. amid the newsmakers and entertainers of the day.

An index of over 250 family names appearing in the book serves as an aid to genealogists. Over 250 endnotes, 70 with photographs, have been included, identifying people, places, and events referenced in the letters. An additional 30 photographs depict Fulton's family, friends and other documents pertaining to him.


