Insurance Tips to Help if Your Home or Car is Damaged in a Winter Storm

North Carolina's recent winter blast has many residents wondering what to do if their home sustains damage due to the snow and ice or if they are involved in an automobile accident. North Carolina Insurance Commissioner Mike Causey offers the following tips to help consumers deal with questions surrounding their property or automobile coverage:

What to Do if Damage Occurs to Your Home

- Call your insurance company or agent with your policy number and other relevant information as soon as possible. Cooperate fully with the insurance company, and ask what documents, forms and data you will need.
- Take photographs/video of the damage.
- Make the repairs necessary to prevent further damage to your property (i.e., cover broken windows, leaking roofs and damaged walls). Do not have permanent repairs made until your insurance company has inspected the property and you have reached an agreement on the cost of repairs. Save all receipts, including those from the temporary repairs covered by your insurance policy.

If your home is damaged to the extent that you cannot

live there, ask your insurance company if you have coverage for additional living expenses incurred while repairs are being made. Save all receipts to document these costs. What Damage to Your Home is Covered? Damage caused by wind, trees or other falling objects, and the collapse of a structure due to weight of ice or snow are all covered under most standard homeowners' policies. Frozen pipes as the result of extreme cold might not be covered if the damage is due to negligence, such as failing to maintain an adequate temperature in the house when the ability to do so is there. Check your policy and call your

insurance agent or company if you need clarification or

What Damage to Your Home is Not Covered? The following events are typically not covered by the standard homeowners' insurance policy: Interior water damage from a storm when there is no damage to the roof or walls of your home; damage as the result of a flood; removal of fallen trees (if the trees do not land on and damage your home); food spoilage due to a power outage; and water damage from backed-up drains or sewers. Some insurers offer endorsements (such as additional protection that may be purchased) for certain coverages not covered under the standard homeowner policy. Check with your agent or company to determine your needs.

What to Do if You Are in an Automobile Accident

Call the police.

- Obtain the following information: The names, addresses, telephone numbers and driver's license numbers of all persons involved in the accident, and any witnesses.
 • Record the time, date, location, road conditions, make
- and year of vehicles involved, apparent damages and injuries, and your version of what happened.
- · Call your insurance agent or company to report the incident as soon as possible. Ask your agent what documents, forms and data you will need.
- Take notes each time you talk with your insurance company, agent, lawyers, police or others involved in the situation. Write down the dates, times, names and subjects you talked about, as well as any decisions or promises made.
- Ask your insurance company if you have coverage for a rental vehicle if your car is not drivable. Save all receipts and bills, including those from renting a car or having your car towed and/or stowed.

Contact the N.C. Department of Insurance If you have a dispute with your insurer about the amount or terms of the claim settlement, or for more information about choosing the right coverage, contact the N.C. Department of Insurance at 1-855-408-1212.

Superintendent Freeman Explains School Closures Last Week

Anson County schools were closed on Wednesday, Thursday and Friday last week due to snow. By Friday morning many of Anson County roads were clear, but cold temperatures Thursday night had created hazardous conditions in some rural areas of the county, especially with ice on the roads.

Superintendent of Anson County Schools Michael Freeman released a statement on Friday, January 19 about the closure of schools on Friday:

I made the decision to close schools in Anson today (Friday) based on the amount of ice covered rural roads in Anson County as well as partially covered side roads within the city limits of various Anson townships. Additionally, the very low temperatures created black ice areas on roads where melting occurred yesterday. Making this decision is never easy, however, when making a decision with the intentions of keeping students and staff safe feel as if I should always make the final determination with extreme caution.

Some of our campuses had a significant amount of ice on driveways, parking lots, and sidewalks late Thursday which was an indicator that these areas were also dangerous for student and staff movement. I expect all of these areas to melt and clear up over the weekend.

A number of our staff members not only travel Anson County roads; they travel from a few hours away. Several of these areas had to close school due to ice covered roads which would mean that we might have an increased number of teachers who had serious traveling challenges. I would rather have instructional time with our students when teachers at work to ensure the highest of quality for student learning.

My plans are to make every effort to protect the traditional spring break our community is accustomed to. Fortunately, we are able to tap into banked instructional time as well as days to document student make up time. Members of my team and I will meet early next week to formulate a plan for making up any necessary time. We will communicate this plan to parents as soon as possible. I do believe that Anson County Schools will be in full operation on Monday. I hope we

will have a full week of awesome instruction next week.

Elementary School Students Recognized by Superintendent and School Board Last Tuesday

Anson County elementary students were given the opportunity to participate in the North Carolina School Boards Association (NCSBA) Elementary Schools Poster Contest where winners were announced at the NCSBA Annual Conference in November 2017.
