#### 1,957 Cases of COVID-19 in Anson

As of Monday, January 25 the Anson County Health Department posted that Anson County had 1,957 reported cases of COVID-19. 190 of those cases were active. At that point they had discharged 1,767 cases, 1,725 to baseline health and 42 deaths.

In a release the Health Department stated, "We are currently vaccinating Phase 1 (Frontline Healthcare Workers) and Phase 2 (Those 65 & Older). If you are interested in a vaccine, please call us at 704-694-5188 and press 1. Please note our call volume is very high, so if you do not reach a person, leave a voicemail and we will call you back. If you have already called and given your specific

and 2, please know we will call you back and have your appointment scheduled within 1-2 weeks.

The NC Department of Health and Human Services (NCDHHS) reported statewide as of Monday, January 25 there were 723,445 total cases of COVID-19, with 8,720 deaths, 8,500,479 completed tests and 3,287 hospitalized

Statewide, as of Monday, January 4 there were 570,111 total cases of COVID-19, with 6,941 deaths, 7,119,201 completed tests and 3,192 hospitalized. On Monday, December 7 there were 404,032 total cases of COVID-19, with 5,605 deaths, 5,678,794 completed tests and 2,373 hospitalized. On November 2 there were 278.028 total cases of COVID-19, with 4,390 deaths, 4,116,019 completed tests and 1,146 hospitalized. On October 5 there were 219,754 total cases of COVID-19, with 3,637 deaths, 3,188,371 completed tests and 971 hospitalized.

#### Health Dept. COVID Vaccine Update

At this time, the Anson County Health Department continues to vaccinate Group 1 and Group 2 per phasing schedule from the state. Anson County Health Director Dr. Fred Thompson doesn't anticipate the state moving to Group 3 for several weeks – maybe sometime in March or April. "We are pretty much done with Group 1, frontline health care workers, and are really focused on Group 2 – the 65 and over, at this point" he said.

Dr. Thompson continued, "The Health Department has about 1,200 people or so with reservations, and is getting hundreds of calls a day from people wanting to get their vaccine – which is good. We have been fortunate enough to get some volunteers from other county departments to assist us in answering the phones. Generally, we are able to get people scheduled within 2-3 weeks after they call, we get their information, add them to the Q if, and only if, we actually have the vaccine available. As reported on the news, the supply of vaccine is very limited at this time."

In order for an individual to get the vaccine they have to be registered in and approved by the state's online portal, the Covid Vaccine Management System (CVMS). When people call the Health Department, staff will get their info and upload it to CVMS. The state uses the CVMS to track the number of doses administered, who they were and to report that info up to the administered to, etc. federal government. That is where the federal government gets the stats that people see on the news about how many doses have been administered in different states, nationally, etc. When the Health Department gives people their shot it is documented in the CVMS that same day. "At some point, people will be able to self-register in CVMS, which would be so helpful," Dr. Thompson said. "It is very labor intensive for the health department staff to have to register thousands of people into CVMS. I'm not sure when people will be able to self-register in CVMS, but I am really looking forward to that day. Dr. Thompson continuted, "We are only scheduling 2-3 days out because the supply of vaccine is so unpredictable. We have enough vaccine for this week, but we won't know until late Friday how much we will get next week – if any. We don't want to schedule unless we know we will have vaccine for those who are scheduled. Too many places have scheduled weeks in advance and then had to turn around and cancel the appointments due to a lack of vaccine.' "They only sent us 100 first doses of the vaccine this week, `and` we are vaccinating 90 to 100 daily," Dr. Thompson said. "The only reason we have enough for this week is that the hospital (Atrium Health Anson) transferred 1,000 of their first doses to us as they have not yet started vaccinating the community in Anson – only their own staff at this point. Atrium Health is vaccinating community members in Mecklenburg, Union, etc. and hope to start in Anson in the next few weeks. That will be a big help. At this point the Health Department and the hospital are the only 'enrolled providers' in Anson County authorized by the state to give the vaccine. We hope that other entities, like ARMS, CVS, etc. will enroll and assist getting the vaccine out to the community over the next few months as the vaccines become widely available. "We also got an allotment of 200 second doses this week (our very first 2nd dose allotment) and the Health Department will start giving people their 2nd dose this week. When people get their 1st dose, we schedule them for their 2nd dose before they leave. The state has promised us that we will have enough second doses for those that have received their first dose. "We are going to set up a second drive-thru bay when we start giving the 2nd doses. One lane will be for first dose and one lane will be for second dose. It is the same vaccine, same amount, etc. but the doses are tracked separately, etc. so it will be easier, and it will allow us to schedule the first and second dose appointments at the same time." Dr. Thompson concluded, "We are vaccinating at the Emergency Services Center, located at 2230 Country Club Road in Wadesboro. We vaccinate from 9:30 a.m. to 11:30 a.m. and then again from 1:30 p.m to 3:30p.m. EMS has been a big help every day — we would not be able to vaccinate at the volumes we are without their ongoing support."

#### Schools Extend Plan C Remote Learning Until February 26

Anson County Schools has made the decision to continue with Plan C, which is 100 percent remote learning, for all Anson County Schools' students through Friday, February 26, 2021. This decision was made due to the increase of community transmissions of COVID-19, to keep our school family safe, and to allow teachers and staff the opportunity to receive the COVID vaccine prior to students returning to school.

All learning will continue remotely. If there are any further changes or updates, the school system will notify all students, parents and staff as soon as possible. Superintendent Howard McLean said, "As always, our priority will be the safety and "

well-being of our students and staff."

When in-person learning resumes on Monday, March 1, schools will begin that week with Cohort A attending in-person March 1 to 4 (March 5 is a remote learning day for all students). Cohort B will attend March 8 to 11, and Cohort C will attend March 15 to 18. An updated school calendar will be shared on the Anson County Schools website s
