Anson County Sheriff Tommy Allen announced on Tuesday that Governor Pat McCrory's office has approved and issued up to a \$5,000 reward for information leading to the arrest and conviction of the person or persons responsible for the November 13, 2013, murder of Keith Jerome Whisnant.

Whisnant's body was found around 8:30 that evening lying beside his car off US Highway 742 North. Whisnant had been shot. He was on his way from Ocean Isle Beach, traveling through Wadesboro. Investigators know that he stopped at the local Burger King around 8 p.m. that night and may to have picked up someone between there and Highway 742.


