Three Men Busted with Meth Lab

Anson County Sheriff's Deputies arrested three suspects on various meth lab charges on Tuesday, January 22nd. Deputies had gone to a residence on Raintree Road that day looking for a suspect from Union County on felony larceny charges. When the suspect fled out the back door he was ar-

rested by deputies, and they then noticed a great deal of debris in the yard that they suspected to be used in meth lab operations

Deputies arrested Kenneth Michael Brower on warrants from Union County. Deputies also arrested Mickey Buddy Gulledge, age 35, of Raintree Road, Jimmy Lee Hildreth, age 22, of Hildreth Road; and Robert Christopher Lowery, age 42, of Lakeview Drive, all Wadesboro addresses. All three were charged with various counts of Possession, and Manufacturing and Distributing Methampheta-Gulledge was placed under a \$200.000 bond and Hildreth and Lowerv were placed under \$100,000 bonds.

Sheriff Tommy Allen said that this was one of the messiest lab scenes his officers have run across. "It basically appears that they just threw their waste, by-products

and other used items out the back door into the back yard. From the cleanup it appears that this operation was ongoing for a while. It was a long clean up time, most of the next day," Allen said.

The Sheriff said that he expects Brower will be charged when he is released from Union County. Other charges may also be pending against the above defendants as well.

Get To Know Michael Freeman, Interim Superintendent of Anson County Schools

A lifetime native of Anson County, Mr. Michael Freeman was recently appointed Interim Superintendent of Anson County Schools effective February 1, with the resignation of Dr. Greg Firn.

Over the past five years Michael Freeman has held several positions in the upper tier of Anson County Schools' educational helm, including Executive Director of Teaching and Learning, Chief Academic Officer, Chief Operating Officer, Deputy Superintendent, and ultimately now, Interim Superintendent.

When asked about his history with the school system Freeman said, "I have been affiliated with the Anson County School System basically all of my life. I attended the public schools of Anson County from first grade through twelfth grade and graduated from Bowman High School in 1980. Following high school I became a substitute teacher with Anson County Schools while attending Anson Community College. After receiving

my undergraduate degree from Pembroke State University I began my teaching career at Anson Junior High School, which was ultimately the point I knew that educating children was my calling and that my career path would be a rewarding one."

While working as a teacher, Freeman did as many educators do and returned to school at night to advance his education. He earned a Master of Arts Degree, North Carolina Educators License in Early Childhood Education, School Administration, Curriculum Instructional Specialist and Educational Mentor. In addition, Freeman earned his Educational Specialist Degree from Winthrop College, which qualified him to advance into school administration with a School Administrators License to include North Carolina Superintendent Licensure. The graduate level work proved valuable and he left the classroom setting and transferred back to Anson Junior High School to serve as an Assistant Principal. AJHS was a very large school, serving students in grades 7-9 in those days. After completing five years in this position he was appointed to serve as Interim Principal at Polkton Elementary School, and eventually became Principal at the newly opened Peachland-Polkton Elementary School. Additionally, Freeman accepted duties to serve in the role of ACS Basic Education Program State Summer School Director, which provided him the opportunity to service students in grades 1-12 and to work with children from every school throughout the entire system. After serving in various roles from substitute teacher, teacher, director, assistant principal and principal he transitioned to the Executive Director: Teaching and Leaning for ACS and eventually became the ACS Chief Academic Officer, Chief Operating Officer, Deputy Superintendent and is currently Interim Superintendent. I asked Mr. Freeman to share with us a little about his life outside of the school system. "Life for me outside of ACS has been very blessed. I was born and raised in Anson County and have enjoyed a simple country life. My parents and family members exposed me to opportunities beyond the geographical boundaries of Anson County - yet I made the choice to remain here at home. My faith has been and continues to be a driving force in life. Attending and professing my Christian faith at both Olivet United Methodist Church in Lilesville and Mount Beulah Baptist Church in Wadesboro has set the tone for my entire life both personally and professionally. I was actually called through experiences in my small county home church to become a teacher after having such wonderful experiences in teaching Vacation Bible School - and yes this blessing truly influenced my entire life," shared Freeman.
