We will seek the highest form of prosecution in all these cases."

In a release from Wadesboro Police Chief Thedis Spencer: The duties of a law enforcement officer are many, from patrolling on foot and in vehicles in communities to prevent crime, to investigating robberies, thefts, homicides, financial crimes, traffic infractions, and the list goes on and on. However, of all the duties of an officer, the most simplest and foundational ones are serving and protecting. All that we do is encompassed in these two fundamental truths. On the eve of Winter Storm Jonas Thursday night, January 21 our officers received a

call that a disabled blind man was missing, and had been for some time. On any day or night this is a troubling matter, but on the eve of a major winter storm it becomes literally a potential life and death situation. Understanding the seriousness of this call, Officers Alex Sherwood and Thomas Luckey, who were just about to end their shift for the day, sprang into action and began an emergency search for the missing blind man, understanding that failure could result in the loss of life. The officers had received information from the wife of the missing man that he had

eft walking with a friend around 1 p.m. and still had not returned nearly five hours later The two were not supposed to be gone long and she was concerned for her husband's safety. The officers were advised by the wife that the other man her husband left with

told her that her husband had decided he was ready to go home, and instead of assisting the man back, the subject he was walking with just turned him around and pointed him in the right direction - an action which could have resulted in a devastating tragedy had Officers established an area to be searched and began looking for the missing man.

The search eventually led Officer Sherwood down a logging road nearly a mile from the

missing man's home where he exited his patrol car and began listening for any sounds in the woods. Fortunately Officer Sherwood did hear something rummaging in the brush and pursued the sound where the missing man was eventually found nearly 25 yards off the logging road in the wooded area. Officer Sherwood identified himself to the missing man and assisted him out of the woods and into his patrol car. The man was in good health when he was located and refused any medical treatment. Officer Sherwood escorted the man home and returned him to the care of his wife, and a tragedy was avoided. Officer Sherwood went back to check on the missing blind man a few days later and

I want to commend the actions of Officers Sherwood and Luckey, for acting swiftly and diligently in finding the missing blind man. As officers we don't always know if our actions help save lives - sometimes it is obvious, sometimes it is subtler. However, on this night it is clearly evident that this man's life was likely saved, and a terrible tragedy and loss to a family was avoided. As an officer there is no greater feeling than knowing that you helped save the life of another, because after all, that is the foundation of what we do - to serve and protect. Job well done men, job well done!
