2,056 Reported Cases of COVID-19 in Anson County

As of Monday, February 1 the Anson County Health Department posted that Anson County had 2,056 reported cases of COVID-19. 156 of those cases were active. At that point they had discharged 1,900 cases, 1,855 to baseline health and 45 deaths.

The NC Department of Health and Human Services (NCDHHS) reported statewide as of Monday, February 1 there were 761,302 total cases of COVID-19, with 9,342 deaths, 8,908,258 completed tests and 2,781 hospitalized. Statewide, as of Monday, January 25 there were

723,445 total cases of COVID-19, with 8,720 deaths, 8,500,479 completed tests and 3,287 hospitalized. As of Monday, January 4 there were 570,111 total cases of COVID-19, with 6,941 deaths, 7,119,201 completed tests and 3,192 hospitalized. On Monday, December 7 there were 404,032 total cases of COVID-19, with 5,605 deaths, 5,678,794 completed tests and 2,373 hospitalized On November 2 there were 278.028 total cases of COVID-19, with 4,390 deaths, 4,116,019 completed tests and 1,146 hospitalized. On October 5 there were 219,754 total cases of COVID-19, with 3,637 deaths, 3,188,371 completed tests and 971 hospitalized.

Due to Limited Supplies, Anson Health Department Temporarily Not Taking **Appointments for Covid-19 Vaccine**

This is a release from Fred Thompson, PhD, Health Director at the Anson County Health Department: As you have no doubt heard on the news, supplies of the

COVID vaccine in North Carolina are very limited.

Unfortunately, we were informed on January 27 that the Anson County Health Department will only be getting 100 first doses of the COVID vaccine per week for the

In light of the 1,200+ people we have registered and are waiting to get the vaccine, we are stopping taking new appointments for the COVID vaccine effective immediately. We will resume taking appointments when/if we get more vaccine allocated to us. Several surrounding counties

We will continue to vaccinate our first doses until our existing supply of first dose vaccine runs out, probably around Thursday or Friday of this week. After that, we will be limited to vaccinating the 100 per week.

In addition, we will continue to give the second dose to people who have received their first dose. The state has said we will get vaccine for the second dose. But, with an allocation of only 100 first doses per week for the next three week, we need to pause taking new appointments and try to work through some of the backlog. Just a reminder, it is critical that everyone continue to

observe the three Ws until this pandemic is behind us – whether they have been vaccinated or not. Thank you and as always feel free to reach out to me

NC Administers More Than 1 Million COVID-19 Vaccine Doses

North Carolina surpassed the 1 million mark of COVID-19 vaccine doses administered across the state last Friday. This milestone capped a week when the state's vaccine providers administered more than 99% of first doses. Now the state's dashboard (covid19.ncdhhs.gov/dash

board/vaccinations) will be updated every weekday so North Carolinians can track the state's administration of COVID-19 vaccines. The state's dashboard is the source for the most accurate and timely information for vaccine data for North Carolina.

"I am so grateful to our vaccine partners across the state

who continue working in innovative ways to make sure North Carolinians have a spot to take their shot. It is incumbent on all of us to use the limited supply of vaccine we have as quickly and equitably as possible, finding new ways to meet people where they are," said NC Department of Health and Human Services Secretary Mandy K. Cohen, M.D.

For the next three weeks, the state is guaranteeing baseline vaccine allocations to providers. In addition, it will set aside doses of the state's allocation to ensure equitable access to underserved and rural communities.

Vaccine supply continues to be very low. There may be wait times. North Carolinians can find out when they will

be eligible to get their vaccine through the online tool, Find My Vaccine Group (findmygroup.nc.gov). The screener walks users through a series of questions to determine which vaccine group they are in. People can then sign up to be notified when their group can get vaccinated. North Carolina is currently vaccinating people in Groups 1 and 2, which include health care workers, long-term care staff and residents, and people 65 and older.

Until the country begins to get ahead of the pandemic. the CDC says everyone should keep wearing a mask,

waiting at least six feet apart and washing hands often. Providing 1 million doses was made possible through the hard work of North Carolina's vaccine providers and their partners, health departments throughout the state.

Special Open Enrollment Period for Health Insurance Starts Soon on *HealthCare.gov...*Only for a Limited Time

North Carolinians have a new opportunity to enroll in health insurance for 2021 on *HealthCare.gov*, but only for a limited time. This new special open enrollment period starts February 15, 2021, and ends May 15, 2021. With job losses continuing to mount amid the COVID-19 resurgence, and millions of

people having lost their job-based health insurance since the start of this public health and economic crisis, the White House has opened up HealthCare.gov to give people who need health insurance a new opportunity to get covered, but they must act quickly. Health insurance is more affordable than many people think. In North Carolina, nine

out of ten marketplace enrollees received financial help that lowered their monthly health insurance premiums in 2020. More than 536,000 North Carolinians enrolled in a health insurance plan for 2021 on HealthCare.gov. Consumers enrolling in a plan on HealthCare.gov are guaranteed to receive

comprehensive coverage, with no pre-existing condition exclusions or markups. All plans cover essential benefits, including doctor and hospital visits, prescription drugs, mental health treatment, and maternity care. In addition, consumers receive free preventive care services, such as immunizations and health screenings. Testing and treatment of COVID-19 are considered essential health benefits and are covered by all HealthCare.gov plans. Consumers should avoid insurance plans offered outside of HealthCare.gov that seem

too good to be true. "Junk insurance" products pose huge financial risks to consumers. These products can refuse to pay for care for pre-existing conditions, charge consumers "NC Navigators stand ready to assist consumers across the state during this special open

enrollment period," said Mark Van Arnam, director of the NC Navigator Consortium. "However, appointments go quickly, so I encourage everyone to act now and schedule

a free appointment with one of our navigators," Van Arnam said. The health insurance landscape can be confusing, but free, local help is available.

Labor **Department Adopts Parental Leave Policy**

The N.C. Department of Labor will implement Executive Order No. 95, Providing Paid Leave to Eligible State Employees, effective Feb. 1, 2021. The executive order applicable to state

legal help to low-income and vulnerable North Carolinians. Learn more at legalaidnc.org employees that qualify for paid parental leave based on the need to care for and bond with a newborn, newly adopted, foster or otherwise legally placed child.

The order grants an employee who gives birth four consecutive weeks for recuperation and recovery and an additional four weeks of intermittent leave for parental bonding. In addition, NCDOL will also offer eligible employees who are non-birth parents four weeks of intermittent paid parental leave for bonding. Qualifying employees will receive 100% of their regular pay while on leave.
