### 2,157 Reported Cases of COVID-19 in Anson County

As of Monday, February 8 the Anson County Health Department posted that Anson County had 2,157 reported cases of COVID-19. 85 of those cases were active. At that point they had discharged 2,072 cases, 2,025 to baseline health and 47 deaths.

In a release the Health Department stated, "We are currently vaccinating Phase 1 (Frontline Healthcare Workers) and Phase 2 (Those 65 & Older). If you are interested in a vaccine, please call us at 704-694-5188 and press 1. Please note our call volume is very high, so if you do not reach a person, leave a voicemail and we will call you back.

If you have already called or filled out a registration form and given your specific information to someone and currently fall within Phase 1 and 2, please know we will call you back and have your appointment scheduled within 1-2 weeks. We appreciate your patience with us!

The NC Department of Health and Human Services (NCDHHS) reported statewide as of Monday, February 8 there were 799,279 total cases of COVID-19, with 9,991 deaths, 9,311,180 completed tests 2,339 hospitalized.

Statewide, as of Monday, February 1 there were 761,302 total cases of COVID-19, with 9,342 deaths, 8,908,258 completed tests and 2,781 hospitalized. January 25 - 723,445 cases of COVID-19, 8,720 deaths, 8,500,479 completed tests and 3,287 hospitalized. January 4 - 570,111 cases of COVID-19, 6,941 deaths, 7,119,201 completed tests and 3,192 hospitalized. December 7 - 404,032 cases of COVID-19, 5,605 deaths, 5,678,794 completed tests and 2,373 hospitalized. November 2 - 278.028 cases of COVID-19, 4,390 deaths. 4,116,019 completed tests and 1,146 hospitalized October 5 - 219,754 cases of COVID-19, 3,637 deaths, 3,188,371 completed tests and 971 hospitalized.

## **Health Department is Now Taking Appointments for Groups 1 and 2**

Group 1 (Health Care Workers) and Group 2 (65 & Over) urged to make appointments

This is a release from Fred Thompson, PhD, Health Director at the Anson County Health Department: Good morning everyone. The Health Department has been able to work through our backlog of people 65 and over waiting to get the Moderna Covid-19 vaccine. We are pleased to begin accepting appointments again for the vaccine for Group 1, health care workers, and Group 2 the 65 and over, effective immediately. To speed up the registration process, for both the Health

Department and the vaccine recipient, we are asking people to fill a registration/health questionnaire and return the form to us. You can request the form via email at coviaregistration@co.anson.nc.us or by calling the Health Department at 704-694-5188. Once completed, the form can be emailed to the same address:

covidregistration@co.anson.nc.us or placed in the drop box located at the front entrance of the Anson Health Department, located at 110 Ashe Street in Wadesboro. Once we receive the registration form, we will call the

individual and schedule their appointment to get the vaccine. For the elderly and others who do not have the capability to fill out the form, they can simply call us at (704) 694-5188 and press 1 and we will take the information manually over the phone as we have been doing. At this point, we have vaccinated 1,966 people. Our

best guess is that we have about 2,000 Ansonians left in Group 2, the 65 and over, to vaccinate. It will take us several weeks to get all of the 65 and over who want the vaccine vaccinated.

I am asked daily, "When will you be able to start vaccinating Group 3, the Frontline Essential Workers?" The only honest answer is that I don't know when the state will move to Group 3. My best guess, and it is just a guess, is sometime in March. We hope that in the coming months vaccine supplies will increase and/or additional vaccinators will come online in Anson County. As a reminder, we are vaccinating at the Emergency

Services Center, located at 2230 Country Club Road in Wadesboro. (Across from Twin Valley golf course.) When people get their first shot, we will schedule them for their second shot before they leave. We now have two drive-thru lanes set up. One is for

people getting their first dose and the other is for those getting their second dose.

Finally, it is critical that everyone continue to follow the 3 Ws after they have been vaccinated. At this point, we simply do not know if people can continue to spread the virus even after they have been vaccinated.

 Wear a cloth mask over your nose and mouth. 2) Wait 6 feet apart. Avoid close contact.

Wash your hands or use hand sanitizer. As always, call us with your questions, and please

encourage everyone 65 and over to get their shot. The Moderna vaccine is safe and effective. To date we have had 2,157 Covid cases and 47 deaths in the county. It is not an overstatement to say that the vaccine can be lifesaving, especially for those 65 and over.

### **Anson County's December Unemployment Rate** at 7.1% Holds Steady from November's 7.2% Rate

Anson County's unemployment rate for December was 7.1%. In November the rate was 7.2%. The October rate was 7.2%, the September rate was 8.5%, the August rate was 8%, the July rate was 10%, the June rate was 7.9%, May's rate was 10.1% and April's rate was 8.2%. In March the unemployment rate in Anson County was 4.9%.

Statewide the December unemployment rate was 6%. In November and October he rate was 6.1%. In September the rate was 7%. In August the rate was 6.8%. In July the unemployment rate was 8.9%. In December 2019 the unemployment rate in Anson County was 4%, and statewide

Anson's total labor force in December was 10,718. Of that number 9,956 were employed and 762 were unemployed. In November the total labor force was 10,8774, with 10,003 employed and 771 unemployed. Unemployment rates (not seasonally adjusted) increased in 55 of North Carolina's

counties in December, decreased in 28, and remained unchanged in 17. Scotland County had the highest unemployment rate at 10.2 percent while Watauga County had the lowest at 4.3 percent.

Four of the state's metro areas experienced rate increases, seven decreased, and four remained unchanged. Among the metro areas, Fayetteville had the highest rate at in-person visits. 8.2 percent while Durham-Chapel Hill and Raleigh each had the lowest at 5.2 percent. The December not seasonally adjusted statewide rate was 6.0 percent. When compared to the same month last year, not seasonally adjusted unemployment

rates increased in 99 counties and decreased in one. All 15 of the state's metro areas experienced rate increases over the year. The number of workers employed statewide (not seasonally adjusted) decreased in

December by 3,616 to 4,681,331, while those unemployed decreased by 3,503 to 297,387. Since December 2019, the number of workers employed statewide decreased 221,241, while those unemployed increased 129,132.
