### **Edgeworth Trial Underway**

The trial of Jerry Edgeworth for the murder of Risden Lyon is underway in Rockingham. District Attorney Michael Parker and Assistant District Attorney Tim Rodgers are leading the prosecution for the state. Edgeworth is charged with First Degree Murder and First Degree Kidnapping in Lyon's case.

Ronnie Burr, who was charged with Accessory After the Fact in the murder, is cooperating with prosecutors in the trial in a plea bargain situation.

Besides the charges in the Lyon murder, Edgeworth is also facing charges of Statutory Rape, Sex Offense with Over Six Year Old, Indecent Liberties with a Child, Crime Against Nature, First Degree Kidnapping, Attempted Second Degree Sex Offense and Assault on a Female.




#### **Open Doors Center for Children**


