### THE EXPRESS • February 13, 2019 • Page 2 Inmates Win Cash Settlements After Suing About Violence at Lanesboro Correctional

Three former inmates at Lanesboro Correctional Institution have been awarded \$62,500 as a settlement to their lawsuits that claimed that they were terrorized by gangs. The inmates' cases were based on the allegation that the former superintendent, Lawrence Parsons, and supervisors would not "clamp down" on the murderous gangs.

The three inmates were among five prisoners who sued after being stabbed by men they claimed were gang members. Their suits claimed that gang members from Bloods and MS-13 were allowed out of their cells by prison guards to carry out the attacks. The five prisoners who were stabbed and sued the prison are Orlando Harshaw, Tavieolis Hunt, Benjamin White, Sean Smith and Stacy Wynn. The prison wing involved was overseen by Jeffrey Wall who was fired in 2013.

Four of the inmates who were attacked were represented by the Southern Coalition for Social Justice. "We hope that the settlements illustrate that people who are in the custody of the state have a right to safety, that administrators have a responsibility to know what's going on in their prisons," said Ian Mance from the Southern Coalition for Social Justice. "The violence in Lanesboro was pervasive, and it should have triggered an intervention and investigation from the state much earlier than occurred. That didn't happen, so these plaintiffs filed a lawsuit in part to get people to pay attention to what was happening there."

Of the five men attacked, Hunt, 39, agreed to drop his lawsuit for \$35,000. He is serving nearly 31 years in prison for statutory sexual offense. White, 35, who last year completed a nearly nine-year prison term for being a habitual felon, received \$14,000. Smith, 38, who is serving nearly 10 years as a habitual felon, will get \$13,500. It has been reported that none of the felons will receive the money directly, instead their attorneys will control the funds in separate accounts. Henshaw, 45, who is serving a life sentence for first degree murder, had sued in hopes of improving conditions at Lanesboro, but dropped his case when it was announced that Lanesboro was being converted to a women's prision.

Wynn's lawsuit accused Parsons of being indifferent to the dangerous conditions at the prison which put inmates' lives ar risk. The suit claimed that Wynn's life was "endangered because the warden didn't rein in Wall, who seemed to favor Bloods gang members, allowed the criminals to attack others, and hid a collection of bloody stabbing weapons in the ceiling of his office," Wynn's attorneys said. He lost the lawsuit in July 2018.

The settlements protect Parsons, who retired in 2016, and several correctional officers. Wall was left out of the settlements to allow inmates to continue legal claims against him, settlement documents said. Wall is negotiating settlements with the inmates which he is paying himself.

Lawyers for the inmates reportedly said Lanesboro was plagued with violence and staff corruption since it opened 15 years ago.

The five inmates were stabbed over a 10-month period in 2011 and 2012 that culminated in inmate Wesley Turner's death. It was reported that Turner was killed by gang members who prison officers allowed to his cell to "hit" his cellmate. Only after Turner's killing did Parsons and state prison officials address the corruption and violence, Hunt's lawsuit said.

State criminal investigators said later that minutes before Turner was killed, two of the three attackers visited the office of an assistant unit manager. Soon afterward, a corrections officer allowed the inmates into the pod where the killing took place, The Charlotte Observer reported in 2014. State Bureau of Investigation agents said they don't know if corrections officers were trying to help the assailants. Bloody homemade weapons were later found hidden in the drop ceiling above Wall's office.

After Wall was fired he was barred from the Lanesboro prison. He tried to force his way back in to retrieve the weapons and videos of his unit hidden in his office ceiling, according to his dismissal letter. Wall also displayed a gun in his vehicle and threatened that he could "get anyone" from outside the prison, his dismissal letter said.

# Free Groceries Available to Eligible Families at BRLC this Saturday and Next Wednesday

Free USDA foods will be distributed this Saturday, February 16 at 2 p.m. or as long as supplies last, and Wednesday, February 20 at 10 a.m. if there are products left at Burnsville Recreation & Learning Center (BRLC). Please note that neighbors will only be served once monthly with these items as long as they last.

All participants who plan to pick up food are asked to bring someone to help them if they need help, as BRLC will no longer be able to provide this support.

The North Carolina Department of Agriculture and Consumer Services Food Distribution Division provide these food items through the Second Harvest Food Bank of Metrolina in Charlotte.

The US federal income guidelines will be a determining factor for individual's eligibility. The food items will only be available to Ansonians. Individuals who have not registered or received food before from the BRLC Emergency Food Pantry must have financial documentation as proof of income to be served. Those families who receive food stamp assistance will automatically qualify. Parents are asked not to bring children due to limited seating space. Neighbors are asked to please park in the parking lot behind the center.
