Free Groceries Available to Eligible Families this Saturday

A new shipment of USDA foods will be distributed this Saturday, February 29, from 12:00 noon until 2 p.m., or as long as supplies last, at Burnsville Recreation & Learning Center (BRLC). Please note that neighbors will only be

served once monthly with these items as long as they last. The items are distributed on a first come, first served basis for eligible Anson County citizens.

All Ansonians who are seeking help with food will need to apply for assistance. (The new year for qualifying began October 1, 2019). * Families or family members who receive federal food assistance automatically qualify.

Children are not allowed during this time.

All participants who plan to pick up food are asked to bring someone to help them if they need help, as BRLC will no longer be able to provide this support.

The North Carolina Department of Agriculture and Consumer Services Food Distribution Division provide these food items through the Second Harvest Food Bank of Metrolina in Charlotte.

The US federal income guidelines will be a determining factor for individual's eligibility. The food items will only be available to Ansonians. Individuals who have not registered or received food before from the BRLC Emergency Food Pantry must have financial documentation as proof of income to be served. Those families who receive food stamp assistance will automatically qualify. Parents are asked not to bring children due to limited seating space. Neighbors are always asked to please fill BRLC's parking lot first. Burnsville Fire & Rescue have made their parking area available for the overflow of neighbors who attend. Please do not arrive before 12 a.m. on Saturday morning.

This internship offers high school girls an opportunity to explore STEM careers in state government

The NC Department of Administration's Council for Women & Youth Involvement (CFWYI) is accepting applications for the annual Lady Cardinal Mentorship Program. The mentorship program is a 5-week summer enrichment opportunity for high school girls in North Carolina who are interested in exploring careers in the fields of science, technology, engineering, and/or mathematics within state More information is at the website: ncadmin.nc.gov. "The Lady Cardinal Mentorship Program nurtures the academic interests in STEM of high school girls, giving them a platform to explore careers that are often dominated by men," said NC Department of Administration Secretary Machelle Sanders. "Lending such opportunities to our young women not only prepares them for the jobs of today and tomorrow but can potentially help reduce occupational segregation among men and women in the workforce and close the current gender wage gap.

According to data released from the 2018 Status of Women in NC: Employment & Earnings Report, women in North Carolina earn a median income of \$36,400, and an average of \$8,600 less than men. Offering paid internships, training, apprenticeships and recruiting women to more high-growth and earning occupations, like engineering and information technology, can help improve the present employment and earnings disparity among women and men across our state and nation. Established in 2019, the Lady Cardinal Mentorship Program offers high school girls hands-on work experience in STEM-related fields, cultivating their career goals while encouraging continuing education. The mentorship program runs June 15 – July 17, 2020. Selected students are assigned to state agencies based on field of interest. Each student will earn a stipend and work a total of 40-hours per week.

Students interested in applying for the 2020 summer mentorship program have until March 13, 2020. To be eligible, students must submit a completed application along with a resume, cover letter and transcript to NC CFWYI's Internship & Youth Council Coordinator, Candace Dudley at candace.dudley@doa.nc.gov or NC Department of Administration's Policy Development Analyst, Emily Roach at emily.roach@doa.nc.gov.
