### **New Hospital Site Designated, Zoning Approved**

Anson County's new hospital received approval for rezoning at their chosen location, 2261 Highway 74 West in Wadesboro. The Anson County Commissioners unanimously approved the rezoning to General Business requested by Carolinas HealthCare System. The zoning had been designated as Highway Business and Residential Agricultural.

The hospital site is 10 acres, near Fresenius Medical Care dialysis center, located on the south side of the highway. Plans are to begin the \$20 million project during this year. The construction is expected to take about 12 to 15 months, with a target to be in operation in 2014. Early plans call for a single story, 47,000 square foot hospital featuring a 24 hour emergency department, 15 beds, a pharmacy, laboratory, surgery services and imaging services such as x-ray, mammography and ultrasound. Mobile services such as MRI will also be available.

### **County Purchases Land for New Agri-Civic Center**

The Anson County Board of Commissioners approved the acquisition of approximately 30 acres of land on Highway 74 East for the construction of a new Agri-Civic Center. The land, purchased from Wade Manufacturing, is located just past Wade Manufacturing, at the intersection of Highway 74 and Morven Freight Lines Road. County Manager Lawrence Gatewood has stated that he hopes construction can begin in

2016 or earlier. The next step will be the design of the facility and site development.

### North Carolina's New Vehicle Tag and Tax Together Program

The North Carolina General Assembly passed House Bill 1779, creating the Tag and Tax Together program - a more streamlined method for vehicle owners to pay their registration and vehicle taxes. Beginning in 2013 annual registration fees and vehicle property taxes will be paid to the Division of Motor Vehicles. In turn, the DMV will distribute the taxes to the appropriate counties. The program was designed to collect vehicle property taxes along with registration renewals and to conveniently pay them together.

If the address on your vehicle registration is current, you will receive a statement that lists both vehicle registration fees and taxes due. Vehicle owners will receive this statement about 60 days prior to their vehicle's registration expiration.

Beginning in 2013 your annual vehicle inspection, registration renewal and vehicle property tax will be due the same month each year. Only one payment - made either in person, online or by mail - is required to pay both the annual tag and tax for your vehicle. Inspection fees are still paid to the inspection station.

The new system will be phased in with the vehicle registration renewals that are due in mid-2013. By mid-2014 all North Carolina vehicles will be incorporated into the system. Your vehicle's annual registration renewal fees will remain the same. The increase in your bill is from the addition of the vehicle property tax. You cannot renew your motor vehicle's registration unless the total taxes and registration fees on the vehicle are paid at the same time. Taxes due on the combined notice are for the coming year, covering the same period as the vehicle registration.

The new Tag and Tax Together program is for your vehicle property tax only and does not affect your mortgage or home property tax.

Once your vehicle becomes part of the Tag and Tax Together program and you have received the combined notice, you will no longer be able to pay your vehicle tax at your county tax office. You can pay three ways: Online at ncdot.gov/dmv. Go the Vehicle Registration Renewal page and pay with your

credit or check card By mail. Send a check or money order to the address listed on your renewal notice.

In person. At the license plate agency in the county government building at 101 South

Greene Street in uptown Wadesboro. If you have questions about your vehicle tax contact the Anson County Tax Assessor's office

at 704-994-3290. If you have DMV-related questions about your vehicle registration under the Tag and Tax Together program call 919-814-1779.

## **Undercover Wildlife Operation Cracks** Down on Poaching in North Carolina, Georgia

State and federal wildlife officials announced today an undercover operation involving more than 80 wildlife violators and as many as 900 wildlife violations detected. Primary violations stem from illegal bear hunting but include an array of wildlife and game law charges. The investigation continues and more charges are possible. The four-year investigation targeted poachers in North Carolina and Georgia, with some work in adjacent states. Officers with the Georgia Department of Natural Resources and the N.C. Wildlife Resources

Commission infiltrated poaching circles to document violations including bear baiting, illegal take of bears, deer and other wildlife, illegal use of dogs, operation of illegal bear enclosures in North Carolina, and guiding hunts on national forest lands without the required permits.

Officers began making arrests Tuesday. Operation Something Bruin partners also include the U.S. Forest Service, the U.S. Fish and Wildlife Service and the National Park Service. "Operation Something Bruin documented hundreds of wildlife violations," said Col. Dale Caveny, law enforcement chief for the N.C. Wildlife Resources Commission. "These arrests

bring an immediate halt to those crimes and, we hope, will make would-be violators think twice before breaking the law." Simultaneous press conferences were held this morning in Asheville, N.C., and Gainesville, Ga., to announce the results of the four-year undercover operation.

"Wildlife is a shared public resource and conservation is a shared responsibility" said Gordon Myers, executive director of the N.C. Wildlife Resources Commission. "North Carolinians can

assist wildlife enforcement officers in their duties by reporting possible violations. We all have a vested interest in safeguarding wildlife from poaching. By targeting wildlife thieves, Operation Something Bruin helps protect our outdoor heritage and conserves wildlife for future generations. Learn more at www.operationsomethingbruin.org.

## In Honor of Black History Month -The Story of "Ralph"

This is a contribution by historian and genealogist Steve Bailey: In Honor of Black History Month - The Story of "Ralph." Ralph's name was also spelled Ralf and, occasionally, Rafe. (Rafe is less well known than that of the other two.) Born a slave in the 1770's, Ralph belonged to Reverend John Culpepper (1764-1841), minister to the Baptist congregation at Rocky River in the Burnsville Community of Anson County. In 1806 Culpeper was elected to the U.S. House of Representatives for the first of six terms, the last concluding in 1829

When he rode off for the District, Culpepper left the church in the hands of his faithful servant, who performed all duties as a supply pastor - among them sermons, weddings, funerals, and the like. Baptist minutes in 1809 list him as "Elder Ralf," while beginning in 1811 his name appears as Ralf Freeman, indicating that he had been freed.

Freeman was popular with members of both races in his home church. He preached to Baptists in neighboring counties and across the Pee Dee region. In the 1820's Elder Ralf rode on horseback to Tennessee to

preach the funeral of his friend, Reverend Joseph McGee. The church congregation took up a offering of fifty dollars to give to Elder Ralf, and wished him a safe journey back to Anson County. Elder Ralf passed away in the 1830's and was buried at

Bethlehem Cemetery on Highway 52 North in Ansonville. A historical marker was erected in the 1960's at the entrance to the cemetery in order to honor and remember Elder Ralf. There have been no records that mentioned who his chil-

dren might have been, but this researcher discovered in the newspapers of 1941 when Reverend W. M. Ratliff preached the homecoming message at West Deep Creep Baptist Church, that it was stated that Rev. Ratliff was a grandson of Reverend Joe Ratliff and great grandson of Elder Ralf Freeman.
