15 finalists from across the state competing

The Got to Be NC Ag Star singing competition wraps up on Saturday, March 4 when a winner will be chosen at the finale concert at 6 p.m. in the Kerr Scott Building on the State Fairgrounds.

Leading up to the finale, semi-final tryouts were held in Fletcher, Greensboro, Mount Olive and Martin County searching for up-and-coming musical performers, with 15 finalists ages 13 to 22 selected.

Got to Be NC's first musical ambassador and country singer-songwriter Paige King Johnson will be performing and serving as the emcee for the Ag Star competition. Finalists include Bryant Brixston, 20, of Durham; Chandler James, 21, of Nashville; Grace Lee, 17, of Wake Forest; Hunter Grant, 21, of Mount Olive; Carson Mac, 19, of Trinity; Kaden Thrower, 20, of Cary; Kristen Toole, 22, of Rosman; Laya Nathan, 15, of Cary; Marye Amanda McDaniel, 22, of Greenville; Nolan Reid, 17, of Coats; Olivia Joy, 22, of Charleston; Reese Mayfield, 17, of Raleigh; Scarlet Tantrum, 19, of Carthage; Sophia Cafaro, 17, of Clayton; and Trenice Atkinson, 20, of Greenville.

The NC Ag Star competition is a collaboration with Johnson. The winner will receive personalized career training from PCG Artist Development of Nashville, a Yamaha guitar, a songwriting session with a professional songwriter and studio recording time, along with opportunities to appear at Got to Be NC events. The winner of the competition will perform at the Mount Olive Ag Fest March 30, opening for country singer Drake White.

Tickets are \$15 and can be purchased in advance through Event Brite or purchased at the door. Fairgrounds entry is through Gate 9, 4285 Trinity Road, Raleigh, with parking in the lot beside the Scott Building.

Seniors, Review, Make Changes to Medicare Advantage Coverage by March 31

Insurance Commissioner Mike Causey and SHIIP, the Seniors' Health Insurance Information Program, remind Medicare beneficiaries about the Medicare Advantage Open Enrollment Period in North Carolina.

[•]Our health can change dramatically within a year's time," Commissioner Causey said. "If you have a Medicare Advantage Plan, now is the right time to make sure you have the plan that best meets your needs."

If you're unhappy with your Medicare Advantage Plan (Medicare Part C), you have options. Each year, there is a Medicare Advantage Open Enrollment Period from Jan. 1 to March 31. During this time, if you're in a Medicare Advantage Plan and want to change your health plan, you can do one of these:

• Switch to a different Medicare Advantage Plan with or without drug coverage

• Go back to Original Medicare and, if needed, also join a Medicare Prescription Drug Plan If you switch Medicare Advantage Plans or go back to Original Medicare with or without a Medicare drug plan, your new coverage will start the first day of the month after your new plan gets your request for coverage. Keep in mind, if you go back to Original Medicare now, you may not be able to buy a Medicare Supplement Insurance (Medigap) policy.

For assistance with Medicare questions, contact NC SHIIP at 1-855-408-1212 Monday through Friday from 8 a.m. to 5 p.m. to speak to a SHIIP counselor. The Medicare Plan Finder (*medicare.gov/plan-compare*) can also help you find, compare and enroll in a new Medicare Advantage Plan or a Medicare drug plan in your area. You can also call 1-800-MEDICARE (1-800-633-4227) for help.

The Medicare Advantage Open Enrollment Period is only for people who are currently enrolled in a Medicare Advantage Plan. If you have a Medicare Advantage Plan and want to change your plan, check out your options today. Remember, the Medicare Advantage Plan Open Enrollment Period ends March 31.

Festival to be held May 19-21 at state fairgrounds



Your Tax Refund Can Support Endangered Wildlife in North Carolina

Officials with the N.C. Wildlife Resources Commission request that anyone filing a 2022 North Carolina state tax return consider donating a portion of their refund to the N.C. Nongame and Endangered Wildlife Fund. Contributions will support research and conservation management projects for the state's most vulnerable wildlife populations.

"The tax-check off program is the most significant source of non-federal funding for projects that support our state's nongame and endangered wildlife species," said Sara Schweitzer, assistant chief of the Wildlife Commission's Wildlife Management Division. "Songbirds, salamanders, frogs and other wildlife species without a designated hunting and fishing season all benefit. The funding benefits game species too because they often live in the same habitats."

Taxpayers can participate by checking line 30 on their North Carolina state income tax form, or by telling their tax preparer they would like to donate. If using tax preparation software, e-filers simply enter the amount they'd like to contribute to the N.C. Nongame and Endangered Wildlife Fund when prompted.

"Any amount goes a long way toward outreach activities and programs. When the Wildlife Commission can match grants using donations, it increases the dollars it can spend on programs.

For example, a \$100 tax refund donation results in an additional \$250 for wildlife diversity initiatives through grants," explained Schweitzer.

If you do not expect a refund but want to support nongame wildlife, direct donations can be made to the N.C. Wildlife Diversity Endowment Fund:
