

In the event that they only have enough for one team, Parks and Rec will abide by the rules listed below: A player is eligible to compete in Division I if he/she does not turn 8 years of age on or before November 1, 2015. A player is eligible to compete in Division I if he/she does not turn 10 years of age on or before May 1, 2016. No Exceptions!

• A player is eligible to compete in Division II if he/she turns 10 years of age on or before November 1, 2015. A player is eligible to compete in Division II if he/she does not turn 12 years of age on or before May 1, 2016. No Exceptions!
