Active Covid Cases Continue to Drop in Anson County

The latest information posted by the Anson County Health Department on Tuesday, March 1 there were 6,507 total Covid-19 cases, with 89 active and 98 deaths. The previous Tuesday, February 22 there were 6,484 cases, with 229 active and 97 deaths.

Covid Vaccines are available for everyone 5 years old and older, including walk-in clinics. (Children 5-11 by appointment only.) Vaccine boosters are available. They are free, and all you have to do is call the Health Department at 704-694-5188 for more information. Walk-in clinics are

held on Thursdays, 8:30 to 11:00 a.m. and 1 to 3:30 p.m. The Health Department is located at 110 West Ashe Street in Wadesboro.

Covid Testing Free testing is available Monday through Friday, 9:30 a.m. to 5 p.m. without an appointment. They are closed for lunch 12 noon to 1 p.m. Testing takes place in the old hospital parking lot at 500 Morven Road in Wadesboro. No appointment is needed and there is no charge.. Results will be called or emailed directly to the person tested or, in the case of children, to their parent or adult caregiver, in 2-3 days. They test anyone over the age of 1. Free home Covid tests are available by mail. Visit www.covidtests.gov or call 1-800-232-0233.

The NC Department of Health and Human Services (NCDHHS) reported that statewide as of Tuesday, March 1 there were 1,231 new cases of Covid, with 22,608 deaths and 1,543 hospitalized.

Ceazar Ryan Rasay Convicted of Sex **Crimes with Child, Recording the Acts**

During the February 14 session of Anson County Criminal Superior Court Ceazar Ryan Rasay was convicted by a jury of Statutory Sexual Offense with a Per-

son who is 15 Years of Age or Younger, Second-Degree Forcible Sex Offense, Taking Indecent Liberties with Children, First Degree Sexual Exploitation of a Minor, Second Degree Sexual Exploitation of a Minor, and Third Degree Sexual Exploitation of a Minor. The case involved Rasay performing

sex acts upon a child while the child was asleep and recording the acts with his phone. Rasay was arrested in November 2017, and was 36 years old at the time.

District Attorney Reece Saunders said, "This case crosses the spectrum of protecting minors, children and those who are helpless. My office is dedicated to being the voice for these victims, and when we establish our own child advocacy center we will better meet the needs of these victims."

The Honorable Stephan Futrell presided over the case and sentenced Rasay to a minimum of 296 months and a maximum of 416 months in the North Carolina Department of Adult Corrections.

The case was prosecuted by Assistant District Attorneys Matthew Victory and Michael Van Buren. Detective Josh Martin with the Anson County Sheriffs Office investigated the case with the help of the State Bureau of Investigations.

State Highway Patrol to Participate In Operation SafeDRIVE

The North Carolina State Highway Patrol will again join forces with law enforcement partners in adjoining states to conduct a concentrated highway traffic enforcement period as part of Operation SafeDRIVE (Distracted Reckless Impaired Visibility Enforcement). Operation efforts aim to eliminate commercial motor vehicle (CMV) traffic collisions through periods of high visibility enforcement along the southeast I-95 corridor where 13% of the nation's fatal CMV collisions occur. The enforcement period will take place March 1-3. "The State Highway Patrol is proud to be a part of this

initiative again in partnership with the Federal Motor Carrier Safety Administration and our law enforcement counterparts throughout the Southeast," said Colonel Freddy L. Johnson Jr., commander of the State Highway Patrol. "We are committed to reducing dangerous driving behaviors on our essential commercial routes. Our aim is to educate and build awareness for all motorists including both passenger vehicle and CMV drivers on how to share the road safely.' SafeDRIVE's enforcement efforts will focus on both

passenger and commercial motor vehicles, and include monitoring for aggressive driving, speeding, tailgating, failing to wear safety belts, distracted driving and impaired driving. Efforts will also help ensure CMV drivers are following industry regulations, including hours of service compliance, commercial driver license compliance, medical certification and commercial motor vehicle credentialing.

SafeDRIVE's enforcement efforts complement a national campaign run by the U.S. Department of Transportation's Federal Motor Carrier Safety Administration, "Our Roads, Our Safety" campaign, which educates motorists on how

to share the road effectively and safely with CMV's. All motorists should follow these safety tips:

 Stay out of blind spots. Large trucks and buses have huge blind spots on all four sides.

• Pass safely. Make sure you can see the CMV driver in

their side mirror. Signal clearly and safely pass the truck or bus. Do not linger in the blind spot. Do not cut off large vehicles. It takes a large truck traveling at highway speeds the length of two football fields to stop.

 Do not tailgate. Tailgating a truck or bus puts you in a The goal of SafeDRIVE is to eliminate highway fatalities due

to CMV collisions. All road users should share the road safely.
