2,298 Reported Cases of COVID-19 in Anson County

As of Monday, March 1 the Anson Health Department posted that Anson County had 2,298 reported cases of COVID-19. 57 of those cases were active. At that point they had discharged 2,241 cases, 2,188 to baseline health and 53 deaths. (The same number of deaths as last week.) The Health Department is now vaccinating K-12 staff and Child Care Workers as part of Phase 3. Health Director Fred Thompson, PhD gave this

update, "We continue to vaccinate Group 1 (healthcare workers), Group 2 (65+) and now Group 3. We are focusing this week on K-12 staff and child care workers, and then we will be expanding to all frontline essential workers on Wednesday, March 10. There are several thousand local workers who fit into

one of the 19 "essential" frontline worker groups as defined by the North Carolina Department of Health & Human Services (NCDHHS). But, really almost anyone who is actually working. It will take some time to get them all (at least those who want the vaccine) vaccinated.

After that we will move to Group 4 (adults with high risk of exposure and underlying medical conditions) and finally Group 5 (anyone who wants the vaccine) We are seeing some vaccine hesitancy in different

groups, ages, etc. Thompson continued, "While North Carolina will be

receiving about 80,000 doses of the new Johnson & Johnson vaccine this week, we have not been told if/when we might get some distributed to Anson. We continue to vaccinate with the Moderna vaccine. It would help/speed things up if we had at least one other

entity in the county vaccinating on a daily basis, but for now the Health Department remains the only one vaccinating on a regular scheduled daily basis. We are vaccinating 100 to 150 people daily, Monday through Friday, and that includes both first and second doses. Atrium Health continues to transfer some their Moderna allotment to us which has allowed us to vaccinate at our current levels, as we are only getting 100 to 200 first doses weekly from the state. Atrium Health took their mobile unit to Morven on

Wednesday, February 24 and vaccinated 212 people which was helpful. Atrium Health will return to Morven with their mobile unit around March 22 for the second doses.

Despite COVID-19 Setbacks, Manufacturing

This is a release from the Anson Economic Development Partnership (AnsonEDP): For the Anson Economic Development Partnership and Anson County in general, 2020 was a year of growth and progress even through a problematic pandemic year.

The Monroe Expressway's impact continued to be felt throughout the year in the form of increased interest in residential and commercial development, especially in the western part of the county. Historically, one of the major stumbling blocks for the Anson economy has been the county's perceived distance to crucial business locations such as Uptown Charlotte and Charlotte Douglas Airport. The Expressway cuts travel time from Peachland to these destinations to about 45 minutes and from Wadesboro to just under an hour. A very significant FDI (Foreign Direct Investment) project announced in 2019. Loba-Wakol, opened its doors. The German manufacturer and distributor of adhesives

headquarters there from Charlotte. The company looked at more than 60 properties throughout the Charlotte metro region before making a decision. "I met with the Economic Development and John Marek, and those guys really did a lot to incentivize us to move our business here and be a big part of this community moving forward," Chief Operating Officer Ashley Carter said. "That was

really our goal. Find a place that wanted us as a partner and that we could also reciprocate the same type of relationship.' Carter and his team are already making connections within the community, especially with the schools. The company wants to offer developmental programs and training for

local students at the high school level and at South Piedmont Community College. 'We wanted to get that out in front of these young people so they know there is a nice opportunity here," Carter said. "Most of the training we do is in the flooring side of the business, so it is a natural fit ... We're really trying to get involved and let

people know that there is an opportunity.' Loba-Wakol already hosts people from around the country in Wadesboro for classes and training. Those people coming from out of state turn to Anson for places to stay,

eat and explore, bringing tremendous economic growth for the area. The facility currently houses administration, sales, warehousing, and distribution light manufacturing, but by 2022 or 2023, the company hopes to add manufacturing

to the campus. Anson Economic Development Partnership (AEDP) also revealed a new business park coming to the county in September of 2020. The Atlantic Gateway Logistics Park, located five miles east of Lilesville, is a partnership between Pee Dee Electric. North Carolina South East, and Anson EDP. This business park will be the new

headquarters for Pee Dee Electric, consolidating Anson and Richmond Pee Dee offices into one central location. AEDP Executive Director John Marek believes there is potential for seven more buildings at the business park. "Those buildings range in size from about 60,000 square feet, up to about 150,000 square feet," Marek said. "Those are appropriately-sized buildings for the purposes

we are talking about, which are warehouse, distribution, and light manufacturing." About 50 acres of the land is north of Highway 74, where the electric company's

headquarters will be located, with an additional 70 acres south of the highway.

The project is estimated to bring 300 jobs such as material handling, forklift operators kickers, packagers, and shipping. Marek estimates the business park will bring between three and five million dollars in annual property tax revenue. It could potentially bring more than \$11 million to Anson's yearly payroll. The Atlantic Gateway Logistics Park was named after the unique location on the strategic

corridor connecting Charlotte and the Port of Wilmington and the Atlantic Coast. Other businesses opened their doors for the first time, demonstrating a robust entrepreneurial spirit, even in these difficult times. A barber school, hair salon,

clothing boutique, and new bakery all opened in Wadesboro. The theater showed off a new art gallery, and beloved Oliver's Restaurant reopened after renovations. AnsonEDP continues to strive towards bringing new business to the county. The team

Governor Cooper Announces Easing of COVID-19 Restrictions as North Carolina Trends Stabilize

is focused on overcoming the pandemic and creating more opportunities in 2021.

Key indicators used to guide decisions throughout pandemic show state's trends are moving in the right direction

As North Carolina's numbers continue to show improvement and vaccine distribution

increases, Governor Roy Cooper announced that the state will carefully ease some of its COVID-19 restrictions. Executive Order No. 195 took effect February 26 at 5 pm and will expire March 26th at 5 pm. "This action is a show of confidence and trust, but we must remain cautious. People

are losing their loved ones each day," said Governor Cooper. "We must keep up our guard. Many of us are weary, but we cannot let the weariness win. Now is the time to put our strength and resilience to work so that we can continue to turn the corner and get through this. 'Keep wearing a mask, waiting 6 feet apart, and washing your hands. We've seen in

the past how fragile progress can be, so we need to keep protecting each other while we get everyone a spot to get their shot," said North Carolina Department of Health and Human Services Secretary Mandy K. Cohen, M.D. The Executive Order lifts the Modified Stay at Home Order requiring people to stay at home and businesses to close to the public between 10 pm and 5 am. The number of people who may gather indoors will increase from 10 to 25, while 50 remains the limit for outdoors. The curfew on the sale of alcohol for onsite consumption will be moved

from 9 pm to 11 pm. Some businesses, including bars and amusement parks, will now be open for patrons indoors as they adhere to new occupancy restrictions. Many businesses, venues and arenas will have increased occupancy both indoors and outdoors Executive Order No. 195 has two general categories of occupancy restrictions: 30% capacity and 50% capacity. Because indoor spaces have a higher risk of spread for COVID-19, indoor facilities in the 30%-occupancy category may not exceed two hundred

Meeting, Reception, and Conference Spaces, Lounges (including tobacco) and Night Clubs, Indoor areas of Amusement Parks, Movie Theatres, Entertainment facilities (e.g., bingo parlors, gaming establishments), Sports Arenas and Fields*, and Venues.* (*Indoor event venues with more than 5,000 seats may be excepted from the 250 person limit if they follow additional safety measures up to 15% capacity.) 50% Capacity Limit Restaurants, Breweries, Wineries, Distilleries, Fitness and Physical Activity Facilities (e.g., gyms, bowling alleys, rock climbing facilities), Pools,

30% Capacity Limit (may not exceed 250-persons in indoor spaces) Bars,

fifty (250) people per indoor room or indoor space.

Museums and Aquariums, Retailers, Outdoor areas of Amusement Parks, and Salons, Personal Care, Tattoo Parlors. Safety protocols such as masks, social distancing and frequent handwashing will continue to be important as people adjust to the new order, health officials said.

COVID-19 County Alert System, which showed 27 red counties - a decrease from 61 red counties on the previous County Alert System - and the fewest red counties in the state since the start of the County Alert System. The update also listed 40 orange counties and 33 yellow counties. **Yellow** = Significant Community Spread **Orange** = Substantial Community Spread

Red = Critical Community Spread Although North Carolina's key metrics remain high, they are moving in a positive direction with decreasing trends in numbers of COVID-19 cases reported each day,

people being hospitalized with COVID-19, people in the intensive care unit and the percent of tests that are positive. Anson County has dropped from Red on February 4 to Yellow. The 14-day case rate
