Enough Fentanyl seized during arrest to kill over 100,000 people

Three others arrested during the investigation

Police Department: On Saturday March 8 at approximately 11:29 a.m. Wadesboro patrol units responded to the CVS, located at 1156 East Caswell Street in Wadesboro. The victim informed officers that she was being followed and when she pulled into the CVS, the vehicle pulled in and fired



multiple rounds into her vehicle. The victim's vehicle had four occupants, two of whom were children, and they were seated in the rear of the vehicle. None of the rounds struck anyone inside the vehicle. The suspect vehicle fled the scene, heading back out onto Highway 74. Officers were able to obtain the suspect's information,

and the on-call Wadesboro Police Detective and Interim Chief were called in to assist patrol units. At the request of the Interim Chief additional Wadesboro officers were also called in to assist. After speaking with the magistrate, officers obtained warrants for the following individuals listed below and a search warrant for the residence on Cherry Street. • Bryant Dewitt Lemon Jr. 28 (No bond) Felony

security while Wadesboro Police executed the search warrant at the residence on Cherry Street. No occupants were located inside. Officers located 232 grams of Fentanyl, which is enough to kill 116,000 people, 639 grams of marijuana, 4 grams of cocaine and drug paraphernalia. Officer also located two firearms, multiple handgun magazines, assault rifle magazines and a large amount of ammunition, to include the same ammunition used in the shooting.
