New Rural Grant Program Launched to Support Downtown Economic Development

North Carolina Commerce Secretary Machelle Baker Sanders announced a new grant program to support the revitalization of downtown districts in the state's rural communities. The Department's Rural Economic Development Division is now accepting applications from local governments for the Rural Downtown Economic Development Grant program. Grants will be awarded by the North Carolina Rural Infrastructure Authority beginning with its April 2024 board meeting and the initial application period for these grants closes at 5:00pm on Monday, April 1, 2024.

The Commerce Department, through our Main Street and Rural Planning Center, has for many years been a hub of knowledge and support for downtown business districts, said Secretary Sanders. "I'm so pleased we're now able to combine our technical expertise with this new source of financial support for rural downtowns across the state.'

The new Rural Downtown Economic Development Grants will support public

improvements that help retain business and attract customers to rural business districts. The program can support publicly owned downtown economic development initiatives that leverage main streets and downtown districts as economic engines, as well as help facilitate publicly owned building improvements that are used for community-wide uses or mixed-use development in or on properties that are publicly owned and controlled. Eligible activities might include improvements to public infrastructure such as lots,

alleys, streetscapes, waterfront developments, and parks. Renovations or additions to public buildings in a downtown district, such as a community or recreation center, a theater, or a library could qualify for grants, as could projects involving publicly owned property zoned and developed for a mix of uses, such as retail, restaurant, or nonprofit uses. Complete guidelines for the Rural Downtown Economic Development Grants are

posted on the Commerce website. The maximum grant amount per awardee is

\$850,000 and may not exceed \$12,500 per projected job created or retained. Grant

administration costs are limited to 5% of the awarded grant total, and applicants must provide a cash match equivalent to at least 5% of the grant amount, with the source of these local matches not derived from other State or Federal grant funds. "The North Carolina Main Street program is one of the leading downtown development programs in the United States, and our entire rural planning team stands second to none," said Kenny Flowers, Commerce's Assistant Secretary for Rural Development. "Downtown districts are one of the most important economic engines for

Investment/Cryptocurrency Scams Riskiest in 2023, According to New BBB Report Investment scams, including those involving cryptocurrency, are now the riskiest scam

type, according to a new report from the Better Business Bureau. More than 80 percent of people who were targeted by this scam type reported losing money to BBB Scam Tracker. It also had the second highest median dollar loss at \$3,800. Investment scams take many forms, including pressure to purchase, trade, or store digital assets (cryptocurrency) with fraudulent exchanges. Investment and cryptocurrency

scams both appeared on the list of ten riskiest scams in 2023. This year, we combined them because most cryptocurrency scams involved some sort of investment opportunity. Employment scam reports remained the second riskiest scam type in 2023. Reports increased 54.2% from the year before. Employment scams had a median dollar loss of \$1,995, significantly higher than the overall median dollar loss of \$100 reported for all

Online purchase (shopping) scams dropped from the riskiest scam type for the first time since 2019, landing at number three on the list. This year, 41.9% of scams submitted to BBB Scam Tracker were online purchase scams, and 82.6% reported losing money.

'Investment and cryptocurrency scams had a significant impact in 2023, particularly for people 45 and older," said Melissa Lanning Trumpower, executive director of the BBB Institute for Marketplace Trust, which produced the 2023 BBB Scam Tracker Risk Report. "People should always beware of opportunities that sound too good to be true. No investment opportunity will come with zero risk."

Key findings of the report include: Scams perpetrated online continued to grow, making up 68.4% of all reports. More

concerning, online scams were more likely to result in a reported monetary loss than scams perpetrated in person or via phone. Overall reported susceptibility (the percentage of reports with a monetary loss) rose

27.8% from 2022 to 2023. Overall reported median dollar loss fell 41.5%. For the second year in a row, people ages 18-24 reported the highest median dollar

• The percentage of people who reported engaging with a scammer via social media rose 63.8% from 2022 to 2023.

 Credit cards remained the most reported payment method with a monetary loss, followed by bank account debit and online payment system. Reports of bank account debit with a monetary loss increased 66.4%.

 Employment scams were No. 1 riskiest for ages 18-44. Investment/cryptocurrency scams were No. 1 riskiest for ages 45+. According to our survey research, people between the ages of 18 and 44 named

anxiety/stress as the number one emotion they felt after being targeted by a scam, while people 45+ cited anger as the number one emotion. The five most impersonated organizations reported to BBB Scam Tracker in 2023:

I Wonder What the N.C. Department of Labor's

Consultative Services Interaction is Really Like The N.C. Department of Labor (NCDOL) has a resource that has been in place for a while that is designed specifically to assist employers with safety and health issues. The

NCDOL offers on-site Consultative Services where a safety and health professional can meet with you virtually or on-site and review your areas of concern. They can review written programs and walk through your establishment to identify worksite hazards that may result in injury. This service is free and does not result in an Occupational Safety and Health (OSH) citation or monetary penalty. "One feature of our service that is great for employers is that they remain in control of the interaction and can guide our visit to meet their needs," OSH Consultative Services Bureau Chief Kevin O'Barr said. He continued, "The program has been around for many

years and many people have an awareness that it exists, but the majority of companies have never actually hosted us on site." The consultants employed in NCDOL's Consultative Services Bureau have years of experience and work across North Carolina. They will identify safety and health hazards in a business and assist with recommendations to reduce and eliminate those hazards. The confidential service has a fantastic bonus – employers who have an open case with

the Consultative Services Bureau are not eligible to be considered for a random OSH inspection. Inspections prompted by an accident, complaint or other unprogrammed event could still proceed. "Taking advantage of this free proactive Consultative Services program will assist North Carolina employers with improving their safety and health programs," Labor Commissioner Josh Dobson said. "We want to partner with the business community to

make North Carolina the safest place to work.' "We can help employers get in compliance with the standards, but more importantly we are hoping to eliminate hazards from the jobsite and help prevent illness and injury to employees," O'Barr said. Does this free expertise come with a catch? No, the only employer obligation is to repair the serious hazards identified during the visit and that is the purpose of inviting the consultant in the first place. If the employer is concerned about the number of hazards being identified, they can stop the visit and work on the issues identified up to that point and then continue through the rest of the facility later.

In order to answer questions for those people considering submitting a request but who remain shy, NCDOL put together a client testimonial video where other employers share their experience with the program.
