Health Department Warns a Difficult Allergy Season Has Begun

Spring in Anson County brings flower buds and blooming treesand if you are one of the millions of people who have seasonal allergies, it also brings bothersome symptoms. Seasonal allergies, also called allergic rhinitis or hay fever, recur yearly and can last for weeks to months on end.

People develop allergies when their body's immune system (your defenders) reacts to substances as though they are a threat to you, and produces antibodies (fighters) to fight it. Your body releases histamines (a chemical) that lead to allergy symptoms. Symptoms include

watery itchy eyes, sneezing, clear runny nose, congestion, dry cough, and itchy throat. Jennifer Dockery, MSN, FNP-C, the Anson County Health Department Physician said, "Pollen is the most common trigger of seasonal allergies, but you could also be affected by grasses and mold. Pollen is the fine powder released from flowering plants in order to reproduce. Pollen is spread by the wind and can be inhaled or land in the eyes or on the skin. If you have seasonal allergies, when your body comes into contact with the allergen symptoms can start."

To help keep your seasonal allergies under control, you can reduce your exposure to things that trigger your symptoms:

• Stay indoors on dry, windy days. The best time to go outside is after a good rain which helps to clear the pollen from the air.

- Delegate lawn mowing, weed pulling and other gardening chores that stir up allergens.
- Wear a pollen mask if you do outside chores.
- Remove shoes and clothes worn outside and shower to rinse the pollen from your skin and hair.
- Don't hang laundry outside to dry-pollen can stick to it.
- Close windows and doors at night or when pollen counts are high.
- Use the air conditioning in your house and car.
- If you have forced heating and air in your house, use high-efficiency filters and follow regular maintenance schedule.

If your symptoms are unrelieved by your normal over the counter medicines, or you have a worsening in symptoms, follow up with your provider. Anson County Health Department schedules same day sick appointments for ages 21+. Please call 704-694-5188 for more information.
