2,404 Reported Cases of COVID-19 in Anson County

As of Monday, March 22 the Anson County Health Department posted that Anson County had 2,404 reported cases of COVID-19. 41 of those cases were active and 56 deaths.

The NC Department of Health and Human Services (NCDHHS) reported statewide as of Monday, March 22 there were 1,248 new cases of COVID-19, with 11,836 deaths and 924 hospitalized.

Statewide, as of Monday, March 1 there were 862,170 cases of COVID-19, 11,254 deaths, 10,291,482 tests and 1,219 hospitalized. February 1: 761,302 cases, 9,342 deaths, 8,908,258 tests, 2,781 hospitalized. January 4: 570,111 cases, 6,941 deaths, 7,119,201 tests, 3,192 hospitalized. December 7: 404,032 cases, 5,605 deaths, 5,678,794 tests, 2,373 hospitalized. November 2: 278.028 cases, 4,390 deaths, 4,116,019 tests, 1,146 hospitalized. October 5: 219,754 cases, 3,637 deaths, 3,188,371 tests, 971 hospitalized.

March 22 and approved Plan A for grades K-5 in-person students that will allow K-5 in-person students to attend school four days per week, every week effective Monday, March 29. Fridays will continue to be a remote learning day for all students. You can refer to the updated re-entry plan at the link below on our website for more details. • Grades 6-13 in-person students will remain on the current Plan B (two rotational cohorts) schedule. • Families will continue to have the option of Plan C (full remote learning) for their

Trends Continue to Stabilize as COVID-19

Vaccine **Eligibility Opens for Some** Members of Group 4

People with high-risk medical conditions or live in certain who congregate settings now eligible for vaccination

Governor Roy Cooper and North Carolina Department of Health and Human Services Secretary Mandy K. Cohen, M.D. gave an update on the state's current data, trends and vaccination progress. Last Wednesday, March 17 marked the opening of vaccine eligibility for people who have a medical condition that puts them at higher risk for severe illness or who live in certain

congregate settings. "With more students in the classroom and millions of people receiving vaccines, there is hope on the horizon,' said Governor Cooper. "But with this virus and its variants continuing to spread, it is too early to let our guard

North Carolina continues to focus on distributing vaccines quickly and equitably. The state has administered over 3.4 million doses. 25.7 percent of those 18 and up is at least partially vaccinated, and 16.5 percent of those 18 and up have been fully vaccinated.

The state is also seeing progress in its continued efforts to emphasize equity in vaccine distribution. Today, the CDC released a report that puts North Carolina among the top ten states in the nation for equitable vaccine distribution.

"We are committed to

using every lever we have to ensure that historically marginalized populations can easily access a COVID-19 vaccine - that includes how we allocate vaccines, who we allocate vaccines to, which events we can support, where we deploy state resources, and who we engage on the ground to help address barriers like transportation and internet access," said Secretary Cohen. Gov. Cooper and Sec.

Cohen also discussed state health officials' ongoing efforts to monitor the presence of COVID-19 variants and stressed the importance of continuing with safety precautions across the state. Recent data shows an increase in these more contagious variants among those infected in North Carolina. People should continue to protect themselves and those around them by practicing the Three Ws-wear a mask, wait 6 feet apart, and wash
