#### **Lilesville Citizens Held Hostage for Over** 12 Hours by CSX Transportation Rail Train

The citizens who live on Cowan Street behind Hatcher's Park in Lilesville were stuck either in or outside of their neighborhood for over 12 hours this past Friday, March 20 when a CSX Railroad train stopped, blocking Cowan Street. Because there is no other ray into or out of the neighborhood, the train blocking the Cowan Street crossing literally



held citizens hostage. The train had been abandoned, with no engineer or other personnel on board. According to Lilesville res-

idents this is an ongoing problem, but usually the blockage lasts an hour or two - not twelve. 82 year old Sarah Har-

rington, a resident of the community, got off her job on Friday evening, looking forward to going home to rest. When she arrived at the crossing at 8:30 p.m. she found it blocked by the train. A call was made to CSX, with a representative

vehicle at the crossing for more than two hours, Mrs. Harrington was too cold and tired to stay any longer. She had to seek shelter with a friend because she couldn't get to her home. "It's been a problem before, but not like this," she said. "I've get to her home. stating that the train would be moved within two hours. After waiting in a chilly

found the train still blocking the track at 2 a.m. "I called CSX at 2 a.m. and was told that the train would be moved within an hour," Sturdivant said. "Sheriff Landric Reid and I monitored the situation, and we were on the scene when the train finally moved away at 9:37 a.m. on Saturday morning. Commissioner Sturdivant continued, "Mrs. Harrington found shelter. There may have

been others blocked from their dwelling, or trapped in their neighborhood. My questions to CSX Transportation are, 'Are you going to reimburse these fine citizens for their inconvenience? When will you stop ignoring this issue? This is unfair to our citizens.' "This has been a continuous problem for years," Sturdivant said. "The late Commissioner Claude Spencer and I were contacting CSX several years ago about this same

issue. Some of the citizens of this community are elderly and have serious medical challenges. This problem becomes of great importance if the train is blocking the crossing when EMS or some other emergency service needs access. Sheriff Landric Reid said, "The train was stopped because of federal regulations

limiting the number of hours that workers can operate the train. If they had to stop here, they should have separated the train cars to open up this intersection. That would have been the easiest thing to do. I also asked CSX why they didn't do that, but they had no answer for that."

Sheriff Reid added, "This is a major safety issue. Abandoning a train while it is blocking

the only way into or out of this neighborhood blocks access for emergency vehicles such as fire trucks, ambulances and law enforcement. This shows a disrespect for the welfare of the citizens of Cowen Street. Perhaps CSX Transportation should respond to this problem, starting with firing the lazy crew who decided to abandon the train. It appears that they were more concerned

My comment to CSX Transportation is everybody is somebody. The way these citizens were treated Friday night showed total disrespect. #### Anson's Unemployment Rate Was 6.5% in January

Anson County's unemployment rate for January was 6.5 percent. In December the ate was 6.3 percent. Statewide the unemployment rate for January was 5.9 percent. Anson's total labor force in January was 10,908. Of that number 10,196 were employed and 712 were unemployed. In December the total labor force was 10.355, with 9,700 employed and 655 unemployed.

Unemployment rates (not seasonally adjusted) increased in 98 of North Carolina's counties in January and decreased in two.

Graham County had the highest unemployment rate at 14.5 percent while Buncombe

County had the lowest at 4.5 percent. All 15 of the state's metro areas experienced rate increases. Among the Metro areas, Rocky Mount at 8.2 percent experienced the highest rate and Asheville and Raleigh, both at 4.8 percent, had the lowest. The January not seasonally adjusted statewide rate was 5.9 percent. When compared to the same month last year, not seasonally adjusted unemployment

rates decreased in 90 counties, increased in seven, and remained unchanged in three. All 15 metro areas experienced rate decreases over the year. The number of workers employed statewide (not seasonally adjusted) increased in Jan-

uary by 1,148 to 4,363,491, while those unemployed decreased 41,534 to 273,212. Since January 2014, the number of workers employed statewide increased 58,444, while those unemployed decreased 44,375.

## Wadesboro is Opening a Recycling Drop-off Site

The Town of Wadesboro is opening a trial recycling drop-off site for residents and small businesses starting Saturday, April 4. The location is the back corner of the Police and Fire Station parking lot, with customers entering from East Morgan Street across from the Anson Rescue Squad facility. The drop-off site will be open on Saturdays from 9 a.m. to 12 noon. Hours may be

expanded as warranted in the future. Wadesboro Town Manager Alex Sewell commented, "Thank you to the Town Council

for allowing staff to try something new to address citizen concerns about recycling op-

portunities. Also, thank you to Town of Wadesboro staff for making this happen. Below is a list of materials that are accepted. Items do not need to be separated by material type and can be commingled.

 What you can recycle: cardboard (flattened); all plastic containers #1 through #7 (free of hazardous materials and food contamination & no styrofoam or plastic shopping bags or plastic film; plastic containers #1 through #5 & #7 (i.e. commercial/retail/automotive); wide-mouth plastic containers; glass bottles & jars; cereal & food boxes; milk &juice cartons, juice boxes; aluminum cans; metal food cans, paperback books; magazines & phone books; shredded paper (in clear bags); empty aerosol spray cans (no paint); spiral paper cans with plastic lids removed (chips, snacks, bread crumbs); rigid plastic containers & small hard plastic toys (HDPE must be less than 2 inches in length & 40 pounds); mixed paper, newspapers with inserts & junk mail.

• What you cannot recycle: contaminated food items; pizza boxes; wire hangers; paper plates, napkins or paper towels; plastic bags; ceramics; pots & pans; styrofoam; pencil shavings; candy or gum wrappers; hardbound books;
