## Anson County's January Unemployment Rate Still Low at 8.6%

Anson County's unemployment rate for January was 8.6%. This was the fifth straight month of single digit unemployment rates locally.

In January 2013 the rate in Anson County was 12.8%.

Anson's total labor force in January was 10,565. Of that number 9,653 were employed and 912 were unemployed. In December 2013 the total labor force was 10,717, with 9,893 employed and 824 unemployed.

Unemployment rates (not seasonally adjusted) decreased in two of North Carolina's counties in January, increased in 96 and remained the same in two. All 14 of the State's metro areas experienced rate increases.

Dare County had the highest unemployment rate at 14.5 percent while Orange County had the lowest at 4.6 percent. Among the Metro areas, Rocky Mount at 10.3 percent experienced the highest rate and Durham-Chapel Hill at 5.3 percent had the lowest. The January not seasonally adjusted statewide rate was 7.0 percent.

When compared to the same month last year, not seasonally adjusted unemployment rates decreased in all 100 counties. All 14 metro areas experienced rate decreases over the year.

The number of workers employed statewide (not seasonally adjusted) increased in January by 2,817 to 4,318,640, while those unemployed increased 19,728 to 325,555. Since January 2013, the number of workers employed statewide increased 69,113, while those unemployed decreased 122,254.

## Dr. Fred Thompson Appointed Anson County Health Department Director

The Anson County Board of Health announced on March 20 that its search for a full time Health Director has been completed. Chairman of the Board, John Ballard stated that following an exhaustive search over the past several months the board is very pleased to announce that Dr. Fred Thompson has been appointed to the health director position. Dr. Thompson will assume his duties on Monday, July 7, 2014, following his retirement as President of Anson Community Hospital.

Ballard stated, "With both a PhD in Health Services and an MBA, combined with almost twenty years of experience in providing a variety of health care services to the citizens of Anson County, I believe Dr. Thompson can offer Anson County, and the Board of Health, a unique combination of education and experience."

Anson Community Hospital is affiliated with Charlotte based Carolinas HealthCare System, Inc., the second largest, public, non-profit hospital system in the US with revenues of over \$7 billion. Dr. Thompson has worked very closely with the Health Department during his tenure at the hospital. He served as Chairman of the Healthy Ansonians, a certified Healthy Carolinians Task Force, which received the Vera S. Robinson Longevity Award in 2011 in recognition of being certified for 15 consecutive years. He also developed one of the largest Parish Nurse programs in North Carolina with over 50 churches participating.

Some of Dr. Thompson's other accomplishments include: his involvement in the construction of a replacement hospital facility to be completed in June 2014; Anson Community Hospital was recognized as a top performing hospital by the Joint Commission in 2013; he established a Provider Based Primary Care Clinic that employs three physicians and a mid level provider; he implemented a Mobile Health Screening Clinic with ten sites around the county.

Dr. Thompson's professional affiliations and community involvement include being a member of the American College of Healthcare Executives, South Piedmont Community College Board of Directors, Wadesboro Rotary Club, Anson County United Way Board of Directors, Anson County Partnership for Children, and he was the recipient of the 2011 Henry W. Little Community Leadership Award. Dr. Thompson is married with one child and has three grandchildren. The Board of Health asked, and interim health director Wayne Raynor agreed to remain as health director until Dr. Thompson begins in July. "We as a board are very excited to be able to bring stability to the health director position and look forward to Dr. Thompson and Mr. Raynor working together for a smooth transition in leadership at the department," Ballard concluded.



Preston Burns' 100th Birthday Celebration with Wadesboro Rotary Club

In 1939, FDR was in his second of four terms in the White House, Hitler triggered World War II with his invasion of Poland, and 26-year-old Preston Burns joined the Wadesboro Rotary Club. On February 27, 2014, the Wadesboro club honored Mr. Burns for his 74 years as a Rotarian and to celebrate his 100th birthday, which fell on February 16.

"Preston's 74 years as a member of this club is astounding in itself," said Wesley Horne, president of the Wadesboro Rotary Club. "But even more importantly, we celebrated his commitment to Rotary and this community. Nobody epitomizes the Rotary motto 'Service Above Self' like Preston." Mr. Burns is a Rotary Paul Harris Fellow and a past president of the Wadesboro club. He was named the club's Distinguished Rotarian in 1994, the second year the award was presented.

He was founder and long-time owner and operator of Wadesboro Auto Supply, and worked diligently for decades as a volunteer with the Anson County Chamber of Commerce. The conference room at the Chamber is named in his honor.

He was also instrumental in economic development in Anson County, assisting with the start-up of such companies as Hornwood, Inc. and Wade Manufacturing Company. Mr. Burns served for nearly 50 years as a member of the Board of Directors of Anson Bank & Trust Company (now Uwharrie Bank), including terms as chairman. He is a member of the First United Church of Wadesboro.

In honor of his then 70 years as a Rotarian, the Anson County Board of Commissioners declared July 22, 2010 as Preston Burns Day in Anson County.

Mr. Burns was married for 66 years to Mary Watkins Burns until her death in 2005. They have three children, Allen Burns (pictued beside his Dad above), Julia B. Schnitker and Katherine B. Griffin.

#### WPD Chief Thedis Spencer Addresses Dog Pack Sightings

In a release from Wadesboro Police Chief Thedis Spencer: The Wadesboro Police Department has recently received several citizen complaints and reports about packs of dogs traveling the streets and neighborhoods of Wadesboro. Officers have located these packs on several occasions, and have attempted to track where they are traveling. Currently our department's resources to effectively handle this situation are limited, however, through cooperation with the new animal shelter being opened in Anson County, and with the citizens, we are developing new strategies to combat this problem both efficiently and humanely.

There are several steps that the citizens of Wadesboro can take now that can help make an initial impact. The main goal of a pack is normally to seek out and locate sources of food. These sources of food are often located in our household waste. We encourage citizens to ensure that any food waste is properly bagged with other trash. Additionally, we recommend not taking your trash to the side of the road until the evening before your scheduled day for pick-up services.

Secondly, a pack of dogs may be in search of female mates. If you own a dog that may be in heat, try to take preventative steps in protecting your pet and property by placing your animal in a shelter or fence that prevents the pet from getting out, or any other animal from getting in. If you have a wireless or underground fence keeping your pet retained to your property, remember that this does not prevent other animals from coming in.

We also encourage pet owners to spay or neuter their pets if you do not have any intentions of professionally breeding them. Spaying and neutering can help prevent an increase in stray animals that can become malnourished or a nuisance. There are several veterinary hospitals in our area that can provide these services. Spaying and neutering is not an expensive procedure and has tremendously positive effects on helping protect the welfare and health of animals. The ASPCA keeps a database on their website that can assist you in finding a lowcost spay & neuter program at www.aspca.org/pet-care/spayneuter. Lastly, it is believed that some of these packs of dogs are actual pets and not just wild stray animals. The Town of Wadesboro has a leash law in effect that requires all animals to be under the constant control of their owners and property. If an animal is able to leave your property due to a lack of control by the owner or a lack of restriction devices, you are in violation of this ordinance. These fines begin at \$25 for the first violation, and can increase for subsequent occurrences. Also, in North Carolina a town ordinance is considered to be a misdemeanor violation. In some circumstances it is possible that you could be arrested for a consistent violation of this ordinance. More importantly, unrestricted animals can attack people and their pets. Animal owners can be held both criminally and civilly liable for these attacks.

We would like to remind our fellow citizens that a pack of dogs are not normally dangerous, however in some situations they can be, and if at all possible should be avoided. Small children and the elderly are especially vulnerable to an animal attack.

If you see a pack of dogs frequenting your area or neighborhood we encourage you to call and report it to us at 704-694-2167. For an emergency Dial 911. By providing us with as much information as possible we can more effectively deal with the situation. Information such as the number of dogs, their individual size, their color and markings, direction of travel and behavior. The frequency in your area, such as time of day and the number of times each week, is helpful to our officers in locating the packs.

I want to let the citizens of Wadesboro know that we take your complaints seriously, and are working hard to find solutions to this situation. With a new animal shelter opening in the county, we will soon have more resources at our disposal. I encourage citizens to follow the recommendations in this press release so that together we can find a humane and efficient solution to this problem. Thank you, Chief Thedis L. Spencer.

#### NCDMV Renews License Plate Agency Contract with County

The NC Division of Motor Vehicles has renewed the contract with Anson County to operate the license plate agency (LPA) in Wadesboro. The previous contract was set to expire this summer. The Division has renewed the contract for three years with options for two 1 year extensions.

The license plate agency is located at 101 South Greene Street in the Anson County Government Building. The agency will maintain the same hours, opening Monday-Friday, 9 a.m. to 5 p.m. The phone number is (704) 994-3292.

The policy of the Division is to open applications to operate a license plate agency whenever a contract expires or ends. Anson County applied during this process to continue operating the agency.

LPAs offer vehicle registration services and title transactions, as well as vehicle license plate renewals, replacement tags and duplicate registrations. Currently about 120 license plate agencies operate across North Carolina.
