Extended Weekend Fly-Fishing **Course Offered for Women Only**

The NC Wildlife Resources Commission will offer a threeday fly-fishing weekend for women on April 5-7 through the Becoming an Outdoors-Woman program. Activities will be held at the Pisgah Center for Wildlife Education and Davidson River Campground, south of Asheville near Brevard, in Transylvania County. The registration fee is \$125, but partial scholarships in amounts up to \$90 are available.

"No previous experience is required," said BB Gillen, outdoor skills coordinator for the Wildlife Commission. This weekend is tailored for individuals, so each angler will gain new skills, improve techniques, and learn about the important role of anglers in conservation of mountain streams.

Fly-fishing equipment will be provided, but participants can bring their own gear. The workshop will be held rain or shine, so bring sunscreen and rain gear. Other needed items include appropriate outdoor clothes, a sturdy hat and water bottle. Camping is optional, with other lodging opportunities located nearby.

The one-on-one instruction includes: • Fly casting • Fly tying • Stream ecology • Knot tying • Basic equipment

On the final day, participants will practice their new skills in a guided fly-fishing experience on prime trout waters.

Becoming an Outdoors-Woman is an international program in which women 18 years old and up can learn outdoor skills through hands-on experiences. In North Carolina, Becoming an Outdoors-Woman workshops are held across the state and provide instruction on fishing, hunter safety, target shooting, archery, canoeing, motorboat safety, outdoor cooking, tracking and map-and-compass orienteering skills.

pest problems and irrigation, the app is a convenient, valuable tool for homeowners and commercial landscapers alike.

'When you're outdoors, whether tending your own lawn or working on a golf course, for example, our app makes it easy to access critical lawn care information right when you need it," said Charles Peacock, professor of crop science and project lead. "It also answers timely questions about situations specific to North Carolina's transitional lawn grasses.

Gleaning information from the Turfgrass Program's popular and widely-used TurfFiles website (http://www.turffiles.ncsu.edu), the app also features a selection of "turf tips" and up-to-the-minute news alerts.

"Due to the state's uncharacteristically warm winter, we're seeing warm-season grasses come in about a month ahead of schedule," Peacock said. "So we created an alert through the app that will help folks tackle this issue.

The app is available for iPhone, iPad and iPod, and android devices. Users without these devices can access the same information through an RSS feed at http://www.lawncare.ncsu.edu. Content is updated regularly by NC State Turfgrass Program faculty. To download the app visit www.lawncare.ncsu.edu.
