Antonio Thomas Robinson Charged in Edward Garris Murder

On Friday March 15 detectives from the Anson County Sheriff's Office and agents from North Carolina State Bureau of Investigation (SBI) arrested Antonio Thomas Robinson, 27, of Wadesboro and charged him with Murder and Possession of Firearm by a Convicted Felon in the March 6 murder of Edward Garris.

On Wednesday, March 6 Mr. Garris was found shot on Sandy Ridge Church Road in Morven. During the investigation Sheriff's detectives and agents with the SBI followed up on leads and collected evidence leading to Robinson's arrest. Robinson was placed in the Anson County Jail with no bond, with a court date of March 25, 2019.

Sheriff Landric Reid said, "I would like to thank the citizens who came forward with information that aided in the arrest of Robinson. I want to encourage anyone with information in this case to contact the Sheriff's Office Investigation Division at 704-694-4188 because this is an ongoing investigation.'

May 14 Date Set for Special Primary Election in North Carolina's 9th Congressional District

Primary Election is set for May 14, General Election set for September 10

A special election will be held on Tuesday, May 14, 2019, to fill the vacancy in North Carolina's 9th congressional district in the United States House of Representatives for the remainder of the 116th United States Congress. The seat has been vacant since the opening of the 116th Congress following the refusal of the North Carolina State Board of Elections to certify the results of the November 2018 election in the district due to allegations of electoral fraud.

Republican Mark Harris led over Democrat Dan McCready in unofficial returns for the 2018 North Carolina 9th congressional district election by 905 votes, the closest race in the district in over sixty years. Although McCready had conceded defeat, the North Carolina Democratic Party alleged that electoral fraud had taken place. They filed affidavits with the North Carolina State Board of Elections alleging that independent contractors working on behalf of Harris had illegally collected absentee ballots. The North Carolina Board of Elections voted unanimously not to certify the election, and they would later order an evidentiary hearing to be held.

The board also opened an investigation around the activities of Leslie McCrae Dowless, a campaign operative with felony fraud and perjury convictions, who was hired by the Harris campaign. Incoming Democratic Majority Leader Steny Hoyer announced that the United States House of Representatives would not seat Harris until the fraud investigation had been completed.

After a delay caused by restructuring of the Board of Elections and delayed appointment of members by Republican allies of Harris, the board set hearings to begin on February 18, 2019. On that day the regulator reported that it had found evidence of "a coordinated, unlawful and substantially resourced absentee ballot scheme" that may ave involved more than 1 000 ballots or ballot request forms. On February 20 Harris's son, John Harris, a federal prosecutor in North Carolina, testified to the election board that he had repeatedly warned his father not to hire Dowless because Dowless appeared to have previously engaged in illegal tactics to win votes.

On February 21 Mark Harris announced that, "The public's confidence in the ninth district seat general election has been undermined to an extent that a new election is warranted." The Board of Elections voted unanimously to call a special election to fill the vacancy. This is the first House of Representatives election to require a "do-over" since 1974. Dowless has been indicted on felony charges.

The Primary will be held on Tuesday, May 14, 2019, with the General Election on September $10,\,2019$, unless a primary runoff is required, in which case the runoff will be held on September 10 and the general election on November 5, 2019. The filing period for candidates ended on March 15. A total of 13 candidates qualified

for the primary, among them 10 Republicans, 1 Democrat, 1 Libertarian and 1 Green. Dan McCready, the Democratic Party nominee in the 2018 election, will run again, and will face no primary opposition. Among Republicans, neither Harris nor Robert Pittenger, the incumbent whom Harris defeated in the 2018 primary election, will run. With the announcement by the State Board ordering a new election, it becomes the second congressional special election in North Carolina in 2019, the other being the

3rd congressional district's special election. The 9th Congressional District of North Carolina is a Congressional district in south-central North Carolina. The district's current boundaries were redrawn in February 2016 after a U.S. District Court overturned the existing boundaries. The new congressional district consists of Union, Anson, Richmond, Scotland and Robeson counties; a southeast portion of Mecklenburg County; and parts of Cumberland and Bladen counties. Republicans have held this district since 1963

The district is 65.17% urban and 34.83% rural. The population in 2016 was 778,477. The median income is \$61,369. The ethnicity of the district is 65.6% White, 19.45% African American, 7.74% Native American, 7.64% Hispanic and 2.53% Asian.
