Free Groceries Available to Eligible Families this Saturday

The Burnsville Recreation & Learning Center (BRLC) Emergency Food Pantry will distribute free food products this Saturday, April 1 at 10 a.m. These foods are provided by the NC Department of Agriculture through the Second Harvest Food Bank of Metrolina. Families will be served until the food runs out - first come, first served.

The US federal income guidelines will be a determining factor for each individual's eligibility and food items will only be available to Ansonians who qualify. Individuals who have not registered before nor received food from the BRLC Emergency Food Pantry must have financial documentation as proof of income to be served. A neighbor who does not have the necessary documentations will not be served. Families that receive food stamp assistance automatically qualify. Each family will only be provided these commodities this month. Parents are asked not to bring small children. Neighbors, please park in parking lot behind center.

BRLC distributes free groceries to eligible families on Wednesdays at 9 a.m. and at other times. You can contact them at 704-826-8182 for information. BRLC is located at 13349 Highway 742 North in Burnsville, across from the Fire Department.

Public Invited to Comment on Migratory Bird Seasons

The North Carolina Wildlife Resources Commission invites citizens to provide input on the upcoming migratory game bird hunting seasons through an online comment system on the agency's website. Comments are submitted by going to www.ncwildlife.org and clicking on the "Migratory Game Bird Proposed Seasons" scrolling icon at the bottom of the page. Migratory game birds include waterfowl, doves, woodcock, rails and snipe. Comments on the season dates will be accepted through April 9.

2017 marks the second year of a new regulatory schedule implemented by the U.S. Fish and Wildlife Service. Previously, the schedule was divided into an early and late season process. The early cycle included seasons for webless species (doves, woodcock, etc.) and waterfowl seasons starting before October 1. Early seasons were normally approved by the Commission in early July. The late cycle included the traditional waterfowl seasons and were typically approved in late August.

The new regulatory process considers all migratory game bird seasons at once. The Commission will select the various season dates at their April 20 meeting and publish the selected seasons in the 2017-2018 Regulations Digest, allowing hunters to make plans in advance of the seasons.

The Commission requests feedback on all migratory game bird seasons, but would like to highlight the season for brant. This year, federal brant season frameworks will allow a 60-day season with a two-bird daily bag. While the currently approved Atlantic Flyway Brant Hunt Plan allows this season, the Commission is increasingly concerned with the status of brant in North Carolina.

Brant are found almost exclusively along the Outer Banks portions of Dare and Hyde counties. State surveys, along with information from local guides and hunters, indicate that brant numbers have fallen dramatically in recent years. As an alternative to the 60-day season allowed by federal frameworks, the Commission seeks feedback on a reduced brant season that overlaps the third segment of the duck hunting season. This would represent no change from the previous hunting season.

Public-input meetings have traditionally been held to receive comments on waterfowl seasons. However, attendance at these meetings declined over time, and public input was minimal at most locations. As a cost-saving measure and to create an easy means for statewide citizen input, the agency developed an online comment system several years ago.

The Commission's website also lists the federal frameworks from which seasons may be selected and a direct link to a map of North Carolina's Canada goose hunt zones. For more information on migratory game birds in North Carolina visit www.ncwildlife.org.

Nature of Work: Work responsibilities for the Morven Town Clerk include the preparation and maintenance of all Council records and other official municipal documents. Record various documents and vital statistics. Work involves extensive public contact in collecting various files and providing information. Work is performed in accordance with the charter, ordinances and general law, and requires initiative, judgement and ability to work effectively and independently with the public and other officials.
