#### **Anson County Has First COVID-19** Positive Test Case

This is a release from the Anson County Health Department: An Anson County resident who tested postive for COVID-19 is being monitored and following isolation orders in Anson County. The test was conducted by Atrium Health. The patient is doing well and is in isolation. She was a contact to a known case of COVID-19, and was not an unknown transmission case.

Anson County Public Health is following Centers for Disease Controls (CDC) guidelines to protect public health and limit the spread of infection. The Anson County Health Department is working to identify close contacts of the individual who tested positive. The CDC defines close contact as being within approximately 6 feet of a person with an infection with COVID-19 case for a prolonged period of time of 10 minutes or longer.

Because COVID-19 is most commonly spread through respiratory droplets, North Carolinians should take the same measures that health care providers recommend to prevent the spread of the flu and other viruses. This involves including washing your hands, avoiding touching your face, staying home if you are sick, and covering coughs and sneezes with your elbow.

It is important to make sure the information you are getting about COVID-19 is coming directly from reliable sources like Anson County Public Health, CDC, and the North Carolina Department of Health and Human Services (NCDHHS). #### **Residents Asked to Reconsider Burning Yard Debris**

# N.C. Forest Service officials urge citizens to reconsider burning yard debris through the end of May, which historically marks the end of spring wildfire season in North Carolina.

Consider alternatives to burning. Some types of debris, such as leaves, grass and stubble, may be of more value if they are not burned but used for mulch instead. "In North Carolina, most wildfires are caused by human action and careless debris burn-

ing. When left unattended, debris burns can escape, igniting tragic wildfires," said Agriculture Commissioner Steve Troxler. "Minimizing the number of escaped debris burns will reduce the risk of wildfires while also reducing the risk of community exposure to COVID-19 by allowing first responders to limit close-contact interactions and maintain ocial distance

During the COVID-19 pandemic, the N.C. Forest Service continues mission critical work such as wildfire suppression and other emergency response functions.

#### **Governor Roy Cooper Announces Statewide Stay at** Home Order Until April 29 to Slow Spread of COVID-19

#### Essential businesses may remain open, social distancing mandated

On Friday, March 27 Governor Roy Cooper ordered people in the state of North Carolina to stay at home for thirty days, until April 29, 2020, in another step to slow the spread of the COVID-19 coronavirus. Governor Cooper's Executive Order No. 121 took effect on Monday, March 30 at 5:00 p.m. and reduces the size of gatherings to 10 people. The Order provides for essential businesses to continue to operate while prioritizing social distancing measures. The Order has the force of law and will be enforced in all 100 counties statewide.

To continue our aggressive battle against COVID-19, I have signed a Stay at Home Order for the entire state of North Carolina. Though it is difficult we must do this to slow the disease spread," said Governor Cooper. "We need our medical system to be able to care for the friends and family we know will become seriously ill from the virus

The Governor noted today that three North Carolinians have died due to COVID-19 and the state has 763 confirmed cases of the virus in 60 counties. He called on all North Carolinians to protect themselves by staying home and following social distancing guidelines. North Carolina is now considered to have widespread transmission of the virus, which means people who have tested positive cannot trace where they were exposed to the virus.

The Order directs people to stay at home except to visit essential businesses, to exercise outdoors or to help a family member. Specifically, the order bans gatherings of more than 10 people and directs everyone to physically stay at least six feet apart from others.

"I know this order may lead to even more hardship and heartache. Although we are physically apart, we must take this step together in spirit," Governor Cooper said.

#### Wadesboro's Most Recent Release Detailing the Town's Actions for COVID-19

This press release from David Edwards, Wadesboro Town Manager, is dated March 30, 2020: Our country is still dealing with the ever-increasing impacts of the novel coronavirus (COVID-19), and though Anson County has still not reported any confirmed cases, the threat to our community is as real as ever. The Town of Wadesboro will always strive to serve our community effectively while balancing the safety and health of our employees as a top priority. To that end, on March 16 and March 20 we announced several measures being implemented to help with that, and effective immediately the following is a comprehensive list of actions being taken:

 Town Hall will be limited to a drive-thru only operation and will be closing on Fridays until further notice. All utility bills can be paid Monday through Thursday, from 8:30 a.m to 5:00 p.m. by using either the drive-thru or calling Town Hall for payment via phone at (704) 694-5171. The outside drop box is also still available 24/7 for your convenience.

• Public entrances to the Police and Fire Stations will be closed until further notice. Please call (704) 694-2167 for information on how to access police reports, accident reports, etc. These services will be pickup only and should arranged in advance via phone.

 Garbage collection will remain on normal operation, no schedule changes are anticipated at this time. However, limb, leaf, and furniture pickup will be suspended until further notice.

• All Town parks will continue to remain open and available at this time. However, all playground equipment and public restrooms are closed and we will not be renting park shelters for public gatherings until further notice.

 Cut-off for nonpayment of utility bills is suspended until further notice. Please note – all usage will still be billed and due as normal, and cut-off will resume at some point in the near future. At that time to be determined by Council the full balance due will be required to avoid cut-off.

 Any further changes to Town services or operating conditions will be communicated via the Town's website (townofwadesboro.org) and our Facebook page.

Unless noted in the order, previous closures and orders stand as written as do ride was originally set for local government orders in cities and counties. Frequently Asked Questions about the Order can be also be found at *governor.nc.gov*.

If you do not think your business is included in the essential services list, and you think it should be, you may apply online at the NC Department of Revenue to be designated essential at www.ncdor.gov. Until your exemption is reviewed, you may operate as long as your business can accommodate social distancing in your workplace.

#### Families to Receive Enhanced Benefits to Ensure Food Access

To help families access food during the COVID-19 pandemic, the North Carolina Department of Health and Human Services is temporarily increasing benefits for March 2020 and April 2020 to current Food and Nutrition Services (FNS) recipients in North Carolina. NCDHHS received federal authority to implement the program from the U.S. Department of Agriculture on March 27.

"People need to be able to feed their families while also practicing good social distancing and following the governor's stay at home order. This will help families make fewer trips to the grocery store and help protect themselves and those in their communities from getting sick," said NCDHHS Secretary Mandy Cohen, M.D.

All families that receive FNS will receive the maximum amount allowed for March 2020 and April 2020 for their household size. For example, a family of four would be eligible to receive a total of \$646 for each of the two months regardless of their usual benefit amount. The increase is subject to the following guidelines:

• Households that have already received the maximum amount for their household size will not receive the temporary increase.

• The household size will not include ineligible or disqualified members.

Households that were ineligible in either March 2020 or April 2020 will not receive a temporary increase for the month(s) they were ineligible.

Approximately 360,000 households will begin receiving the temporary increased benefit on their Electronic Benefit Transfer (EBT) card on April 1 and April 22. They will be randomly generated and staggered every other workday until all eligible households have received their temporary increase.

Recipients will continue to receive their regular benefits and should be aware they will receive two separate payments for March and two for April.

To help limit the spread of COVID-19, NCDHHS has also received approval to extend FNS certification periods so that beneficiaries don't have to visit county Social Services offices to qualify for continued services.

In addition, with many businesses closing to reduce the spread of COVID-19, work requirements for able-bodied adults without dependents are being temporarily and partially suspended. All eligible beneficiaries are being notified of this change.
