of the Sheriff is the safety and security of all citizens. In order to accomplish this, my administration will focus on many areas including:

DRUGS/VIOLENT CRIME:

My administration, along with support from the community, local government, District Attorney's Office, local, state and federal law enforcement agencies, the faith based community and other resources will seek to adopt a "Focused Deterrence" strategy to fight the ongoing drug and violence problem in this county.

This strategy allows for the identification of our most at-risk and violent drug offenders. Offenders with multiple drug convictions and a demonstrated history of violence will be aggressively targeted for prosecution. Other at risk offenders will be "called in," confronted with the consequences of their continued behavior, and given a "final warning" to cease their criminal activity. Those who wish to "heed the warning" will be offered assistance to ensure they remain out of the criminal justice system. Those who choose to continue their illegal activities will be dealt with swiftly and feel the full weight of local, state and federal law enforcement efforts.

We must send a clear message that we will not tolerate illegal drug dealing or violence of any kind in our county. We must also send a clear message that we are here and willing to help those who want to help themselves.

PROPERTY CRIME:

Property crime has been and continues to be one of the most prevalent types of crime we experience in this county. One of the most effective ways of investigating these crimes is quick access to pawn shop information.

It is no secret that most stolen property will eventually find it's way to a pawn shop or drug house. Through a computerized pawn tracking system deputies will have instant access to records from pawn shops, second hand stores, metal recyclers and precious metal dealers.

The system also allows officers to put repeat offenders on a "watch list" that will notify the Sheriff's Office anytime anyone on the watch list sells or pawns an item at a participating business.

The system also has an added benefit which allows Anson County residents, at no cost, to enter their personal property information into the system, protected by a personal username and password. In the event a citizens property is stolen they can go into the system and retrieve photos of their property along with serial numbers. This allows law enforcement a much greater opportunity to locate and return stolen property.
