#### Free Self Defense Classses Offered


The Anson County Domestic Violence Coalition is offering free self defense classes. These classes are offered in conjunction with the month of April's Sexual Assault Awareness Month.

#### **Special Election Period for Some Medicare Beneficiaries**

Universal Health plans terminate; beneficiaries have one-time option to change coverage

More than 2,700 Medicare beneficiaries in North Carolina are eligible for a special election period due to the cancellation of Medicare Advantage plans issued by Universal Health Care and Universal Health Care Insurance Company. Universal was ordered into receivership by the state of Florida for the purposes of rehabilitation and liquidation. Contracts for coverage provided by Universal through plans such as Any Any Any and Hassle Free were terminated on April 1, 2013. Beneficiaries will not experience a lapse in coverage; the Centers for Medicare & Medicaid Services have automatically enrolled those affected in Original Medicare and stand-alone prescription drug plans offered through Humana, United, Coventry and Envision. Beneficiaries are to be notified of the contract termination and coverage changes by mail.

- Through May 31, 2013, affected beneficiaries have a one-time option to:
- Select another Medicare Advantage or Medicare Advantage Prescription Drug plan; or

 Stay with Original Medicare and also enroll in a Medicare Supplement (or Medigap) policy; or Stay with Original Medicare but change the CMS-generated enrollment to another prescription drug plan.

SHIIP, the Seniors' Health Insurance Information Program, can provide free, unbiased information and enrollment assistance to former Universal beneficiaries. SHIIP, a division of the North Carolina Department of Insurance, can be reached during standard business hours at 800-443-9354.

"We want to make sure that everyone affected by the termination of Universal's Medicare plans understands their rights and options," said Wayne Goodwin, North Carolina insurance commissioner. "SHIIP staff members stand ready to assist with any questions about Medicare coverage.

Beneficiaries can also call 1-800-MEDICARE for assistance. If calling Medicare directly, beneficiaries are instructed to tell the operator that they are a "Universal beneficiary" and that they need to discuss their new coverage.

In North Carolina, Universal policies were issued in 26 counties. In Anson County there were 52 policies.

SHIIP is a division of the North Carolina Department of Insurance that offers free, objective information about Medicare, Medicare prescription drug coverage, Medicare Advantage, longterm care insurance and other health insurance information. #### **Carolina Farm Credit to Issue Patronage Checks**

In April, member-borrowers of Carolina Farm Credit will receive patronage refunds checks for 2012, Michael R. Morton, CEO, announced. The amount of patronage to be paid and revolved in the future for borrowers of Carolina Farm Credit will total \$14.7 million. Borrowers will receive a refund of 20 percent of the interest that accrued on their loans in 2012. A cash refund of \$4.4 million will be paid, and the remainder will be placed in allocated capital accounts for future revolvement.

"Carolina Farm Credit had another successful year in 2012. We're pleased to be able to share our success with our borrowers by putting our profits in their pockets," said Joe Lail, Chairman of the Carolina Farm Credit board. "This is the 25th consecutive year we've paid a patronage refund. In addition, the board of directors plans to continue to retire the allocated surplus according to their plan in the fall of 2012. Since 1988, Carolina Farm Credit has declared patronage totaling more than \$385 million to be paid to its member-borrowers through

#### **Cheers! Inaugural NC Beer Month Has Begun**

Brewing a new tradition, North Carolina rings in spring with its inaugural Beer Month as a testament to the state's influence in the craft beer business. Sponsored by the North Carolina Brewers Guild and the North Carolina Division of Tourism, Beer Month takes in special tours, tastings, dinners, classes, festivals and lodging packages celebrating local variations on this heady beverage.

Toast North Carolina's beer craftsmanship and the destinations where it thrives with these seven fun facts in honor of the month-long beer fête:

North Carolina is home to nearly 85 breweries — more than any other state south of Pennsylvania and east of Texas, according to a Beer Association survey. The newly released "State of the Craft Beer Industry" report for 2013 shows North Carolina setting the pace for growth of new breweries with a 23 percent increase in 2011. Three major craft breweries have chosen the Asheville area for East Coast expansions: Oskar Blues (which opened in Brevard in December), Sierra Nevada (Mills River, opening mid-2013) and New Belgium (Asheville, opening 2014).

In the space of a year, Charlotte saw three breweries - NoDa, Birdsong and Heist open within half a mile of each other in the lively NoDa neighborhood. Asheville has reigned as Beer City USA since 2009, either winning the poll or tying for the top spot every year. The city has 14 breweries, half a dozen beer festivals and the popular Asheville Brews Cruise. North Carolina is home to the nation's first solar-powered brewery (Outer Banks Brewing Station in Kill Devil Hills) and the first LEED Gold brewery (Mother Earth Brewing in Kinston). North Carolina has become synonymous with craft beer, from Spring Brew, a 2012 World Beer Cup Gold Award winner from Wilmington's Front Street Brewery, to First Frost, a Good Food Award winner from Durham's Fullsteam Brewing, and a host of "bucket list" beers.
