#### **Public Hearing Scheduled Concerning Moratorium** for Proposed Flea Market on **Faulkner Road in Peachland**

A public hearing is scheduled for Tuesday, April 16 concerning a moratorium for the proposed Flea Market on Faulkner Road in Peachland. The Anson County Board of Commissioners unanimously approved in open session that a public hearing be held to determine whether a moratorium on flea markets shall be adopted.

The public hearing will be held during the upcoming Commissioners meeting.

The Board of Commissioners will meet on Tuesday, April 16, beginning at 6:00 p.m., and will hold the public hearing to receive public comments on whether a moratorium on flea markets shall be adopted. Comments will be restricted to the subject of the hearing as advertised and all speakers are asked to address the Board in a civil and courteous manner. Each speaker will be limited to three minutes subject to additional informational requests and questions from the Board.

The meeting and public hearing will take place in the Anson County Commissioners' Board Room on the second floor of the Anson County Government Center, located at 101 South Greene Street in uptown Wadesboro.

## **Consider Visting Morrow Mountain State Park**

Less than a 45 minute drive from Anson County, Morrow Mountain State Park has a lot to offer.

Located in Stanly County near Badin, Morrow Mountain State Park provides a myriad of adventures from the summit of the namesake mountain, along the banks of the Yadkin River State Trail, and to the shores of Lake Tillery. The mountain is a study in geologic wonder - with Native American artifacts made of rhyodacite to argillite mined by the Civilian Conservation Corps (CCC) to create many of the park's structures. One of these

CCC-built structures is the state parks system's only day-use swimming pool. Activities Hiking (14 trails, 37 miles); Horseback riding (19 miles); Paddling; Swimming (pool, seasonal); Fishing; and Picnicking.

Camping Vacation cabins; Tent sites (including backpacking sites); Trailer and RV sites (some with electric hookups); Group tent sites; Dump station; Showers; and Firewood. Amenities Boat ramp; Boat rentals (seasonal); Concession stand (seasonal); Amphitheater; Community building; Picnic shelters; Museum and exhibits; Bathhouse; and Horse trailer parking.

Field Trips North Carolina state parks staff proudly offer numerous memorable field trip experiences for students and teachers. Explore science, history, social studies, and math through sampling stream life or climbing a mountain.

There are no fees required to access Morrow Mountain State Park for day use, except for boat rentals and swim passes. Fees are also charged for camping, certain event permits, and facility reservations.

Pets are allowed at the park and at campsites. They are not permitted at the pool, inside buildings, or in vacatioin cabins. Pets muct be on an attended leash of no longer than 6 feet at all times.

The park opens at 7 a.m. year 'round. It stays open until 10 p.m. May through September, until 9 p.m. April and October, 8 p.m. March and November, and 7 p.m. January, February and December. The park office is open daily from 8 a.m. to 4:30 p.m. (Hours may change on state holidays and weekends.)
