### Third Man Charged with Church Vandalism

A third suspect has been arrested in association with the November 14th vandalism of Cedar Hill AME Zion Church. Jacob Andrew Schrimpsher, age 18, from Oakboro, NC was arrested early Monday morning, April 9th in Stanly County and is now in the Anson County Jail. On Monday, April 2nd deputies arrested Bryan Matthew Balser, age 21, of Albemarle, and as of last week officers expected to bring charges against Daniel Tyler Huneycutt, age 19, who was already in the Rowan County jail. The three men are facing charges that include Breaking and Entering a Place of Worship, Felony Larceny and Burning a Church Building, and Damage to Property.

Schrimpsher's bond has been set at \$500,000. Balser's bond was set at \$1,000,000.

The men are believed to have been involved in numerous church and business property vandalism in Anson, Stanly and Rowan Counties. Eventually all the suspects will be brought to Anson County to stand trial after their charges in Rowan County have been disposed.

Damage to the Cedar Hill church was in the tens of thousands of dollars. All repairs have been made and a rededication of the church was made last month.

Sheriff Tommy Allen said, "All three suspects have been charged and are in custody. At this I don't expect further arrests in this matter.

### **Unemployment Rate 11.2% for February**

Anson County's unemployment rate in February was 11.2%, almost one percent lower than January's 12% rate. Statewide the unemployment rate for February was 10.1%, January's rate was 10.5%.

Looking back at February 2011, the rate then for Anson County was 12.8%. This February's rate of 11.2% reflects a continually improving situation locally.

Anson's total labor force in February was 10,862. Of that number 9,648 were employed and 1,214 were unemployed. In January the total labor force was 10,912, with 9,608 employed and 1,304 unemployed.

Unemployment rates fell in 84 counties of North Carolina's 100 counties in February. Rates increased in 10 counties and were unchanged in six. Unemployment rates declined in 81 counties when compared to the same month last year.

"A majority of North Carolina's counties have lower unemployment rates compared to last year," said N.C. Department of Commerce Deputy Secretary Dale Carroll. While the over-the-year numbers are positive, we must continue our focus on job growth across the state. We have employment service offices statewide to assist customers with job search opportunities and other workforce related programs.'

North Carolina had 34 counties that were at or below the state's seasonally unadjusted unemployment rate of 10.1 percent. Unemployment rates decreased in 13 of the 14 Metropolitan Statistical Areas.

Statewide the number of workers employed (not seasonally adjusted) increased in February by 17,939 to 4,184,386 and those unemployed decreased 13,965 to 472,573. Since February 2011, the number unemployed decreased 27,787 and the number employed increased 82,956.

Orange County had the state's lowest unemployment rate in February at 6.3 percent. Graham County had the highest unemployment rate at 20.7 percent.

It is important to note that employment estimates are subject to large seasonal patterns; therefore, it is advisable to focus on over-the-year changes in the not seasonally adjusted series.

County and other local area benchmarked labor force statistics are still under review by the Bureau of Labor Statistic and may be subject to revision

### **Forest Service Provided Wildland Fire Control Trucks to Three Anson County Fire Departments**

Recently the NC Forest Service delivered three military 2 1/2 ton trucks to Wadesboro, Ansonville, and Lilesville Fire Departments. These trucks are to be used for wildland fire

Ansonville Fire Department already has their new truck in service and it has responded to several fires this spring. Wadesboro and Lilesville should have their trucks

ready to respond in the upcoming months. The trucks came newly refurbished by the United States Army. All of them have new diesel engines with less than 10,000 miles on them. Vehicles like these trucks are screened from military bases across the eastern US and the best trucks are brought back for use here in North Carolina. # **Anson County Board of Commissioners Approve Plan For New** Healthcare Facility in Anson County

#### Estimated cost to develop and build the new facility is about \$20 million

The Anson County Board of Commissioners last night approved a plan submitted by Carolinas HealthCare System (CHS) to develop an innovative, comprehensive healthcare delivery model in Anson County. The new facility will offer residents superior access to healthcare including unique services designed to better address both inpatient and outpatient needs.

"We're extremely pleased that the County Commissioners have approved our plan. We regard their action as a vote of confidence in our ability to address the changing healthcare needs in Anson County and our commitment to addressing those needs today and well into the future," said Dennis J. Phillips, Executive Vice President for CHS.

The approval of the Commissioners paves the way for CHS to proceed with filing a Certificate of Need application in June with the state of North Carolina for the new facility. The Anson Centennial Project will focus on building strong relationships between patients and primary care providers and partnering with other local organizations to improve the overall health of residents through coordinated and enhanced access to targeted health services.

The project proposed by CHS includes replacing the existing hospital with an innovative new facility at a new location that includes:

- Multi-purpose patient rooms
- 24-hour emergency services
- Surgery and imaging
- Pharmacy and laboratory

· Better access to primary care that features a "patientcentered medical home approach"

In addition, CHS plans to develop and implement creative community partnerships in Anson County that. among other things, may result in a mobile dental clinic, comprehensive patient navigation to assist patients who need a broad array of medical services, transportation assistance, faith-based community health programs and wellness services to the community.

In his presentation to Commissioners Tuesday evening, Phillips conveyed Carolinas HealthCare System's passion for this inventive initiative.

"Like so many communities across the country, the vision we have for Anson County is really a vision for communitybased care where the changing needs of the population are outpacing existing models and outmoded facilities," Phillips "We are committed to improving the community's said. health through a delivery system that encourages collaboration among health professionals and a cost-effective new facility.'

Phillips also presented the timeline for completion of the project, including design and construction. If the CON is granted by the state, CHS anticipates the new facility will be completed in mid to late 2014. The Lillie Bennett Nursing Center will remain in operation as it is now.
