Poverty is loaded word. People have differing views of what it means to be poor. Some think that poverty is just the lack of money, but in reality what people face is more than that. They face the lack of resources, the lack of spiritual and emotional support, the lack of financial planning, the lack of education - all of which leads them to live in poverty without escape.

Instead of trying to understand this complex concept, we invite you to come and experience what it is to live in poverty for one day. Starting at 9:30 a.m. on Saturday, April 21, Anson NETworX for Hope and the Anson-East Union Mission Network will present a workshop, "Bridges Out of Poverty," at First United Methodist Church (FUMC) in Wadesboro. The workshop will be led by Annette Snider, the NETworX USA/NC Coach. She has been involved with initiatives to end poverty in North Carolina since 2009. Snider is a certified trainer of Dr. Ruby Payne's A Framework for Understanding Poverty, and a certified trainer for Bridges out of Poverty.

Following a light lunch, a Poverty Simulation will be held from 12:30 to 3:30 p.m. Through role-playing, attendees will "walk in the shoes" of families struggling with poverty and learn about real life problems they face.



Child Abuse Prevention Month is spreading the message that everyone can invest in children and families to give children the safe, stable, nurturing environments and relationships they need to thrive.

"North Carolinians are already involved in activities that prevent child abuse and neglect, they just don't realize it,' said Sharon Hirsch, President and CEO of Prevent Child Abuse North Carolina. "We are working to educate the public about how they are already helping to prevent child abuse, as well as offering some positive ideas about how we all can help children and families thrive." A study commissioned by Prevent Child Abuse America shows that only 27% of Americans report that they are engaged in prevention. However, that same study showed that:

 80% of Americans reported donating goods, money or time to an organization supporting children and families, and 70% reported volunteering to work with children through places of worship, schools, and sports or academic clubs

Prevent Child Abuse North Carolina, Anson County Partnership for Children and Anson County Domestic Violence Coalition are encouraging North Carolina residents to learn more about how three specific actions – mentoring children and parents, advocating for family-friendly policies, and donating time and money – relate to child abuse prevention. On Monday, April 2 new board members were installed at the Anson County Board Elections. of Upon calling the meeting to order, newly confirmed members for the current term (which ends on July 1, 2019) were administered the



oath of office. Democrat members James Paxton and Annie Parsons were given the oath by Anson County Clerk of Superior Court Mark Hammonds. Republican members Rochelle Williams and Tracy Baynard were administered the oath by Elections Director Steve Adams. Recent law changes added an additional member to local boards of elections, as well as the office of Vice-Chair.

After the oath was administered and the new board seated, Adams welcomed the incoming board and opened the floor for nominations of a Board Chair. James Paxton was nominated and unanimously approved to serve as the Board Chairman. Rochelle Williams was nominated and unanimously approved to serve as Vice Chair, while Tracy Baynard was nominated and unanimously approved to serve as Secretary to the Board.

Local Board of Elections members are nominated by County Party Chairs and submitted to the NC State Board of Elections for approval. Due to a recent law change and court proceedings, the prior board, whose term was to end in June 2017, held over until March 31, 2018

Prior to the newly confirmed board taking the oath of office, Elections Director Adams recognized the outgoing board and its members with remarks and plaques of appreciation for their service.
