#### **Anson EDP is now AnsonEDC**

This is a March 31 release from the Anson Economic Development Corportation: What's in a name? A lot, actually. Over the past week, we have begun rolling out a change in our corporate identity. The majority of people likely will not even notice, but those with a keen eye for detail might see we have replaced "Partnership" with "Corporation" on our website and social media accounts. Technically, this is not a name change. We have been Anson Economic Development Corporation since 1975, and all of our official business transactions have been conducted under that name for nearly fifty years. In 2016, however, we entered into an agreement with Anson County and hired our first full-time executive director. At the time, it seemed like a good idea to highlight this new arrangement by

broader government and quasi-government representation. While this unofficial identity has helped positively position the organization in the public eye, the discrepancy in what we call ourselves and our legal name has generated some confusion with vendors, government reporting, and funding sources, and with changes in elected officials and QGO leadership over the past seven years, the two boards are now virtually the same. As such, it was agreed at the last Partnership and Corporation board meetings to eliminate the use of "partnership" and consolidate the two boards. This change is being rolled out over a 30 to 60-day period, with the website, email, and social media accounts changing this week and new printed materials

#### and signage in place by June 1st. Frequently Asked Questions:

- Does this have anything to do with the recent changes in Chamber of Commerce leadership? No. This change was in the works since the first of the year. The timing was just a coincidence.
- How does this change impact the leadership of the organization? There will be no change in organizational leadership. Don Scarborough was the chairman of both the Partnership and Corporation boards and will remain chairman of the Corporation board. Our executive director, John Marek, was always a paid employee of the Corporation and will continue to lead the organization in that role. His email address is now: John@AnsonEDC.com.
- What about contact information such as email addresses websites, phone numbers, etc.? We are changing our email addresses, website URL, and social media account tags to reflect the new corporate identity. The new website address will be ansonedc.com, and the email addresses will be [first name]@ansonedc.com. Our main phone number has changed to 704-787-5896, but our executive director's 24/7/365 line will remain the same. We will continue to support the old website URL and email addresses for at least six months.

#### **Escapee from Anson Correctional** Captured within 10 Hours of Escape

Stephon Easterling, an inmate at Anson Correctional Facility, walked away from his work release and escaped with the assistance of Amy Brigman. Easterling was a felon with a scheduled release date of February 2024. Easterling had Brigman pick him up and the two left the work site.

Information on both suspects and the vehicle they were driving was given out in a "Be On The Lookout' (BOLO) by Anson Communications. Using technology available to law enforcement, the vehicle that Easterling and Brigman were in was picked up by a Flock camera system in Richmond County. Agencies worked together throughout the day, and within 10 hours Brigman and Easterling were in custody.

The Polkton Police Department said that they would like to thank all the agencies that helped with this investigation: Anson County Sheriffs Office, Richmond County Sheriffs Office, NC DPS (DOC), and Anson Communications.

Easterling was charged with Escape, and Brigman was charged with Harboring a Fugitive and Felony Aid and Abet escape.

### **Anson February Unemployment Rate**

Anson County Anson County's unemployment rate for February was 4.0%. Anson County ranked #65 of 100 counties statewide (low to high).

Here are other past rates in Anson County: 2023: January 4.3%. **2022**: December 4.0%; November 4.6%; October 4.9%; September 4.2%; August 4.9%; July 4.7%; June 5.3%; May 4.7%; April 4.6%; March 4.9%; February 5.1%; January 5.1%. **2021**: December 4.4%; November 4.7%; October 5.2%; September 4.9%; August 5.8%; July 6.5%; June 6.1%; May 5.5%; April 5.4%; March 5.9%; February 7.5%; January 7.7%. The 2020 rates were: 7.1%; November 7.2%; October 7.2%; December September 8.5%; August 8%; July 10%; June 7.9%; May 10.1%; and April 8.2%.

In March 2020 the unemployment rate in Anson County was 4.9%, just before it was affected by the pandemic. Statewide the unemployment rate for February was

Anson's total labor force in February was 10,289, with

9,877 employed and 412 unemployed. In January the total labor force was 10,280, with 9,841 employed and Unemployment rates (not seasonally adjusted) decreased

in 74 of North Carolina's counties in February 2023 increased in five, and remained unchanged in 21. Hvde County had the highest unemployment rate at 10.6% while Orange County had the lowest at 2.8 percent.

Twelve of the state's metro areas experienced rate decreases and three remained unchanged. Among the metro areas, Rocky Mount had the highest rate at 5.2 percent while Asheville had the lowest at 3.0 percent.

When compared to the same month last year, not seasonally adjusted unemployment rates decreased in 74 counties, increased in 13, and remained unchanged in 13. Twelve of the state's metro areas experienced rate decreases over the year, one increased, and two

remained unchanged. The number of workers employed statewide (not seasonally adjusted) increased in February by 13,486 to 4,979,802, while those unemployed decreased by 4,564 to 186,006. Since February 2022, the number of workers employed statewide increased 35,804, while those unemployed decreased 4,369.


