2,454 Reported Cases of COVID-19 in Anson County

As of Monday, April 5 the Anson County Health Department posted that Anson County had 2,454 reported cases of COVID-19. 25 of those cases were active and 56 deaths. The NC Department of Health and Human Services (NCDHHS) reported that statewide as of Monday, April 12 there were 1,469 new cases of COVID-19, with 12,290 deaths and 904 hospitalized.

Statewide, as of April 5 there were 1,054 new cases of COVID-19, with 12,173 deaths and 907 hospitalized. March 29 there were 1,372 new cases of COVID-19, with 12,085 deaths and 873 hospitalized. March 1 there were 862,170 cases of COVID-19, 11,254 deaths, 10,291,482 tests and 1,219 hospitalized. February 1: 761,302 cases, 9,342 deaths, 8,908,258 tests, 2,781 hospitalized. January 4: 570,111 cases, 6,941 deaths, 7.119,201 tests, 3,192 hospitalized. December 7 404,032 cases, 5,605 deaths, 5,678,794 tests, 2,373 hospitalized. November 2: 278.028 cases, 4,390 deaths, 4,116,019 tests, 1,146 hospitalized. October 5: 219,754 cases, 3,637 deaths, 3,188,371 tests, 971 hospitalized. Recent history in Anson County: March 31, 2020: 1 case; April 28 - 23 cases (no deaths); May 26: 62 cases (1 death); June 22: 107 cases (2 deaths); July 27: 285 cases (2 deaths); August 31: 440 cases (4 deaths); September 28: 605 cases (4 deaths); October 26: 720 cases (9 deaths); November 30: 937 cases (14 deaths); December 31: 1,444 cases; (28 deaths); January 25 1,957 cases (42 deaths); February 22: 2,258 (53 deaths); March 1: 2,298 cases (53 deaths); March 29: 2144 cases 56 deaths); April 5: 2,433 cases (56 deaths).

At Home COVID-19 Testing Now Available for People with Disabilities

Getting tested for COVID-19 is about protecting yourself and your loved ones. To help ensure everyone has access to COVID-19 testing, the NC Department of Health and Human Services, in partnership with NC-based Labcorp, has launched a pilot program to provide 35,000 no-cost, at-home COVID-19 test collection kits for North Carolinians who may face difficulties traveling to testing sites.

Eligible North Carolina residents can request a Pixel by Labcorp COVID-19 PCR Test Home Collection Kit be shipped overnight directly to their homes by visiting *pixel.labcorp.com* or calling (800) 833-3935. The test kit includes test supplies (nasal swab, sample container, etc.), detailed instructions and prepaid specimen return shipping materials to make mailing samples back to Labcorp for testing easy and convenient. Results are typically reported back to the individual within 24 to 48 hours from the time the specimen is received at the lab. Once processed by Labcorp, test results are accessed by the customer via the Pixel by Labcorp website.

North Carolina's COVID-19 Vaccine Eligibility Opens for 16 and Older

Last week Governor Roy Cooper and North Carolina Department of Health and Human Services Secretary Mandy K. Cohen, M.D. gave an update on the state's current data, trends and vaccination progress as April 7 also marked the opening of vaccine eligibility for Group 5. This means anyone 16 years and older who wants a safe and effective COVID-19 vaccination is eligible to get one.

"We remain focused on getting people vaccinated as quickly and as equitably as possible and continuing to slow the spread of the virus," said Governor Cooper. "The more people we vaccinate, the more we can safely do." North Carolina continues to focus on distributing vaccines quickly and equitably. To date, the state has administered over 5.2 million doses. 39 percent of those 18 and up is at least partially vaccinated, and 26 percent of those 18 and up have been fully vaccinated. "These tested, safe and effective COVID-19 vaccines will help us get back in control of our lives and back to the people and places we love – like safely hugging a grandmother, traveling to see vaccinated family or friends, or having a potluck dinner with your vaccinated neighbors," said Secretary Cohen. State health officials are continuing to monitor the presence of COVID-19 and its more contagious variants in North Carolina, which is why it is important to continue to follow the state's mask mandate and practice safety precautions, including the Three Ws - wear a mask, wait 6 feet apart, and wash hands often.

Unemployment Rate Rose in February

Anson County's unemployment rate for February was 7.5%, down a bit from January's 7.7% rate. In December it was 7.1%. In November the rate was 7.2%. The October rate was 7.2%, the September rate was 8.5%, the August rate was 8%, the July rate was 10%, the June rate was 7.9%, May's rate was 10.1% and April's rate was 8.2%. In March 2020 the unemployment rate in Anson County was 4.9%.

Statewide the February unemployment rate was 5.6%. In January and December the rates were 6%. In November and October the rate was 6.1%. In September the rate was 7%. In August the rate was 6.8%. In July the unemployment rate was 8.9%.

Anson's total labor force in February was 10,610. Of that number 9,815 were employed and 795 were unemployed. In January the total labor force was 10,576, with 9,764 employed and 812 unemployed.

Unemployment rates (not seasonally adjusted) decreased in 96 of North Carolina's counties in February, increased in three, and remained unchanged in one. Scotland County had the highest unemployment rate at 10.9 percent while Orange County had the lowest at 4.0 percent.

All fifteen of the state's metro areas experienced rate decreases. Among the metro areas, Fayetteville had the highest rate at 7.8 percent while Durham-Chapel Hill and Raleigh each had the lowest at 4.7 percent. The February not seasonally adjusted statewide rate was 5.6 percent.

When compared to the same month last year, not seasonally adjusted unemployment rates increased in 99 counties and decreased in one. All 15 of the state's metro areas experienced rate increases over the year.

The number of workers employed statewide (not seasonally adjusted) increased in February by 46,644 to 4,722,326, while those unemployed decreased by 14,589 to 281,902. Since February 2020, the number of workers employed statewide decreased 215,747, while those unemployed increased 107,577.

2021 NC Strawberry Season Underway

April signals the start of strawberry season in North Carolina, and local growers are optimistic about the 2021 season and anticipate a crop that should last through Memorial Day.

"The recent hard frost kept strawberry growers busy protecting the plants' tender blooms, but farmers have reported that those efforts seem to have been successful and consumers will be able to find local berries," said Agriculture Commissioner Steve Troxler. "I enjoy seeing fresh North Carolina strawberries at pick-your-own farms, roadside stands, farmers markets and grocery stores. I know they will be the freshest and best tasting berries available."

North Carolina ranks fourth nationally in strawberry production, growing 1,100 acres of strawberries annually.

Last year, the strawberry season began around the time the first COVID-19 case was diagnosed in North Carolina. Growers responded by taking additional measures to protect employees and consumers, including installing additional hand washing stations; providing hand sanitizers for employees and customers; requiring employees to wear disposable gloves while handling produce; and ensuring sick employees stay home.

In addition, several pick-your-own farms encouraged social distancing by limiting the number of rows that could be picked and limiting groups to 10 people or less. Many strawberry farms are continuing the practices started last year for this season.

The N.C. Strawberry Association will host two contests on its Facebook page, @NCStrawberry. A recipe contest and a strawberry photo contest will be held during the strawberry season, and winners will receive a prize. Visit the association's Facebook page to enter the contests, beginning April 15.
