Town of Wadesboro Enacts Curfew for People 18 and Younger

On Thursday, April 9 the Town of Wadesboro issued a proclamation of a municipal state of emergency to take effect the following day, Friday, April 10. The proclamation, signed by Mayor Bill Thacker, enacted a curfew in the town limits of Wadesboro for people 18 years old or younger, from 9 p.m. until 6 a.m. The proclamation stated the following:

Section 1: Pursuant to the Town of Wadesboro State of Emergency Ordinance and Chapter 166A of the North Carolina General Statutes, as well as Article 36A Chapter 14 of the General Statutes. I have determined that a State of Emergency, as defined in the Town State of Emergency Ordinance, does exist in the Town of Wadesboro.

Section 2: I, therefore, proclaim the existence of a State of Emergency in the Town of Wadesboro. **Section 3:** I hereby order all Town law enforcement officers, employees, and any other

emergency management personnel subject to my control, to cooperate in the enforce-

ment and implementation of the provisions of the Town State of Emergency Ordinance

which are set forth below. **Curfew.** Unless a member of the Town's law enforcement agency or the emergency services, or determined to be an essential employee as defined by Governor Cooper's Executive Order 121, every person under the age of 18 years who is located within the incorporated area of the Town of Wadesboro is to be inside a dwelling from the hours of

9:00 PM until 6:00 AM. This curfew shall not apply to those persons under the age of 18 who are seeking emergency medical attention, or are otherwise directed to be outside a dwelling by state, local, or federal government personnel.

Section 4: This proclamation is for the incorporated areas of the Town of Wadesboro.

Section 5: This proclamation shall become effective on Friday, April 10, 2020. Proclamation this the 9th day of April At 10:50 a m. This proclamation once effective will

Anson Has 12 Reported Cases of COVID-19 as of April 14

On Tuesday, April 14 the Anson County Health Department reported that Anson

County has 12 reported cases of COVID-19, with 6 of those cases active. Two of the cases are from community spread, meaning that the patient does not know where they came in contact with the virus, and the individual had no risk factors.

As of Saturday, April 11 the Health Department reported ten cases of COVID-19

in the county.

One case involves a healthcare worker who was caring for confirmed cases in

another county.

Six cases have been discharged. Discharged means the individual has maintained the

following guidelines: At least 7 days have passed since symptoms first appeared, and at least 3 days (72 hours) have passed since recovery defined as resolution of fever without the use of fever-reducing medications and improvement in respiratory symptoms (e.g., cough, shortness of breath).

The Health Department advises everyone to please continue to observe the following:

1- You should assume EVERY person you come in contact with is potentially infected. Regardless of where you go (down the street or to another zip code, grocery store or fast food).
2- You should assume EVERY surface is potentially contaminated.

3- You should cough into your elbow or your sleeve, NOT your hand (see reason #2).

4- You should be following the governor's stay at home order.

5- You should be following proper hand hygiene.
6- Practice social distancing (6ft)

7- If you exhibit symptoms of COVID-19 such as fever, cough, body aches, WITHOUT

shortness of breath, difficulty breathing or chest discomfort- you are asked to stay home and recover, you do NOT need to be tested, you can self isolate at home, which reduces exposure to others.

8- If you have been around a positive case and have no or even mild symptoms, you do

NOT need a test. A positive test result is going to do NOTHING for you. You will only be exposing more persons by seeking this test.

9- Consider Atrium Health's online virtual assessment for COVID-19 and the FREE virtual

visit. If a doctor's note is what you need to stay home from work, they can provide you with one, pending that a note is necessary and you are symptomatic. It is important to make sure the information you are getting about COVID-19 is

It is important to make sure the information you are getting about COVID-19 is coming directly from reliable sources like Anson County Public Health, CDC, and the North Carolina Department of Health and Human Services (NCDHHS). NC Insurance Commissioner Causey Helps Insurers Offer Discounts to Policyholders

North Carolina Insurance Commissioner Mike Causey is working with insurance companies so they can provide financial assistance to consumers during the COVID-19 health emergency. Many automobile insurers are announcing rebates and discounts due to the "Stay at Home" order, but, by law, rebates are not allowed in North Carolina and discounts must be filed in advance with the Department for approval. As an alternative, the Commissioner has developed a filing mechanism that will quickly allow companies to legally offer discounts to help their policyholders. "This plan provides companies with an expedited way to bring economic relief to our

residents," said Commissioner Causey. "I cannot ignore our laws that do not allow monies to be given to policyholders that are not tied to a decrease or cancellation of coverage. I can, however, assist companies in offering legal discounts," he added. Insurers who would like to offer an assistance plan to consumers during the COVID-

19 emergency must contact the N.C. Department of Insurance Property and Casualty Division at 1-855-408-1212.

Policyholders should contact their insurance carriers to see if their company is offering

a financial assistance plan.

Monday Thunderstorms Result in Anson County Emergency Declaration In a brief post on their Facebook page, Anson County Government stated the following:

Due to the significant damage Anson County suffered during the thunderstorms on the morning of Monday, April 13th, 2020, a State of Emergency has been declared.

Anson County's Unemployment Rate was 4.5% in February

Anson County's unemployment rate for February was 4.5%. No unemployment figure

for Anson County was released for January, but the December rate was 4.0%. Statewide the unemployment rate was 3.7% in February, down slightly from January's 4.1% rate.

Anson's total labor force in February was 11,098. Of that number 10,603 were

employed and 495 were unemployed. In December the total labor force was 10,563 with 10,137 employed and 426 unemployed.

Unemployment rates (not seasonally adjusted) decreased in all 100 of North Carolina's

counties in February. Hyde County had the highest unemployment rate at 13.3 percent, while Buncombe and Orange Counties each had the lowest at 2.9 percent.

All 15 of the state's metro areas experienced rate decreases. Among the metro areas, Favettovilla, had the highest rate at 4.9 percent and Ashevilla and Durham-Changl Hill.

Fayetteville had the highest rate at 4.9 percent and Asheville and Durham-Chapel Hill each had the lowest rate at 3.1 percent. The February not seasonally adjusted statewide rate was 3.7 percent.

When compared to the same month last year, not seasonally adjusted unemployment rates decreased in 96 counties, increased in three, and remained unchanged in one.

All 15 of the state's metro areas experienced rate decreases.

The number of workers employed statewide (not seasonally adjusted) increased in February by 55,157 to 4,933,849, while those unemployed decreased by 17,601 to 189,127. Since February 2019, the number of workers employed statewide increased 85,929, while those unemployed decreased 22,619.

The Commission urges anyone who is using the game lands for an outdoor activity beyond turkey hunting to wear an article of clothing featuring blaze orange, which will alert
